Victims

The Palestinian refugee “Mohammed Qassem Ahmed,” from the ranks of the Palestine Liberation Army, has died while fighting alongside the Syrian regime, in the ongoing clashes in the town of Hazrama, in the eastern Ghouta region. He was a resident of the Khan Danon camp in the suburbs of Damascus.



Latest Developments

In its annual documentational report for 2017, titled “The Palestinians of Syria... Between Promises and Restrictions,” which was issued in the beginning of February, AGPS announced that the residents of Al-Husseiniya camp suffered in 2017 from harsh humanitarian and living conditions, as a result of the continuing conflict in Syria, and complained of the tight security imposed on the camp, the raids and arrests carried out by the Syrian regime and the popular committees affiliated to it on their homes. The report indicated that the Syrian security arrested a number of Palestinian men on 05-07-2017, identifying “Mohammed Salem,” from the

Sabinah refugee camp, who was arrested while visiting his relatives in Al-Husseiniya camp under the pretext of drug abuse, which was denied by a number of residents and activists.

While Palestinian refugees confirmed that a number of houses owned by Palestinian refugees in Al-Husseiniya camp in the suburbs of Damascus, were dominated by families attributed to the Syrian regime, indicating that these families are from the Shiite community.

Palestinian refugees accused the Syrian regime and its loyal sectarian groups in the suburbs of Damascus, of exploiting the absence of Palestinian families and bringing families loyal to them and families of fighters with the regime, and housing them in those homes.



The Action Group's report, which was prepared by a group of researchers specialized in the affairs of refugees, showed that similar cases occurred in Al-Zyabeyeh, in the suburbs of Damascus, where some returnees to the area were able to enter and forcibly share their homes with pro-regime families.

The activists had confirmed that almost 40% of the residents of Al-Husseiniya camp for Palestinian refugees in the suburbs of Damascus, are not allowed to return to their homes and properties by the regime's army until the moment.

Al-Husseiniya camp for Palestinian refugees in the suburbs of Damascus witnessed the return of some Palestinian families to it on 16-08-2015, after the regime army's ban on its displaced population for nearly two years.

In another context, AGPS's documented statistics reveal that the number of Palestinian refugee victims who have died because of the Syrian war has reached 3646 victims, since 2012.

As for the reasons for their death, the statistics indicate that 1149 refugees died because of the exchanged bombardments between the Syrian regime forces and the armed Syrian opposition groups. 970 refugees lost their lives during the fighting between the regime and the opposition, while 477 refugees lost their lives under torture, during their interrogation in the prisons and detention camps of the Syrian regime.

309 refugees died due to sniper shots, while the siege imposed on the Palestinian camps by the Syrian regime and some of the Palestinian factions affiliated to it, has led to the death of 201

Palestinians, as a result of malnutrition and the lack of health services.

While the remaining for a variety of other reasons, including bombings, summary executions and drowning during attempts to reach Europe.

All Palestinian refugee victims in Syria are documented by the Action Group, regardless of their political positions or the body responsible for their deaths.

In Yarmouk camp, ISIS crucified four men, the day before yesterday. Two men were crucified at the Orouba checkpoint, while the other two were crucified near Palestine Mosque in the camp.

According to our correspondent, ISIS's justification for the crucifixion of the men is that they smuggled some simple furniture from their homes from the areas of its control to Yelda, which is prevented by the organization, while the crucifixion process lasts for three days from morning until every afternoon of the three days.



This comes amid an unprecedented escalation of the violations implemented by the regime on the residents of the camp. In the past

few days, summary executions have been carried out on Palestinian refugees.

In another context, the Syrian regime continues to detain Palestinian “Jamal majid Al-Jaafary,” born in 1983 and resident of Yarmouk camp, for the third consecutive year. He was arrested at the Syrian regime’s Town Center checkpoint in the town of Sahnaya, Damascus on 15/06/2015, then taken to an unknown place. No information about his fate or location have been revealed since.

AGPS receives a number of messages and information about the detained Palestinians. They are then documented despite the difficulty of recording information because the Syrian regime continues to hide the fate, names and locations of the detainees. The Group has recorded the detention of 1644 Palestinian refugees in the Syrian regime prisons, including more than 105 women.
