Latest Developments

AGPS took part in a workshop held by the UN Office of the High Commissioner for Human Rights – Syria about the methodology of documenting human rights violations.

The workshop was held between December 06-08.

The three-day workshop tackled issues related to international humanitarian law, international human rights law, and the foundations of human rights documentation.

Exercises about making interviews, report drafting, data and witnesses protection were made. The workshop also tackled documentation of human rights abuses in/about Syria and accountability mechanisms.

AGPS is a London-based human rights watchdog that monitors the situation of Palestinian refugees in war-torn Syria. In seeking to fulfill this goal, AGPS team does its best to uphold the finest standards of historiographic ethics and maintain honesty in sourcing. To that very end, live snapshots, footages, and sworn affidavits are taken directly from the fighting scene across a myriad of flashpoints so as to authenticate AGPS role as a human rights overseer.

In another development, Palestinian refugees and activists have slammed the Secretary of Popular Palestinian Committees North of



Lebanon, Abu Maher Ghanoumi, for forcing two Palestinian families out of the Badawi refugee camp, north of Lebanon.

Eye-witnesses told AGPS that Ghanoumi threatened to kill activists and force families out of the camp in case they continue to speak up against his abuses.

Ghanoumi denied claims about having forced two families out of the Badawi camp.

A few days earlier, Popular Committees for Palestinians of Syria condemned in a statement issued on Thursday, December 9, the displacement of two Palestinian families from the Badawi refugee camp, in the northern Lebanese city of Tripoli.

The committees slammed counterfeit reports claiming Palestinian refugees are forfeiting their right of return and seeking asylum in European destinations.

The statement called on Palestinian diplomats and activists in Lebanon to immediately step in and urge chief of the Follow-Up committee in AlBadawi Camp to step down.

The statement said all Palestinian refugee families who fled wartorn Syrian to Lebanon continue to show their strong commitment to their right to return to their homeland, despite the ad hominem campaigns waged against them in an attempt to undermine such an inalienable right.

In another development, Palestinian Ambassador in Damascus Dr. Samir AlRefa'i visited on Thursday, December 9, AlAyedeen Camp



for Palestinian refugees, in Hums, to inspect the humanitarian condition in the camp.

The Ambassador said the embassy is making every possible effort to assist Palestinian refugees in displacement camps across wartorn Syria.

Over recent years, the embassy has come under heavy criticism due to its apathy regarding the dire humanitarian situation endured by Palestinian refugees in/from Syria.

Meanwhile, Residents of AlHusainiya Camp have raised concerns over their children's safety as packs of stray dogs have been spotted in and around the camp and outside of schools.

The refugees appealed to the concerned authorities and NGOs to take urgent action over the spread of feral dogs in the camp and to work out the chronic power outages in the area.
