Victims

A 20 —day Infant "Mohammed Jameil Al Assar" died due to the lack of medical care and malnutrition in the besieged Yarmouk camp, raising the siege victims' toll to 171.

The AGPS received news about the death of the young man "Ahmed Al Qadi" in the Syrian regime prisons due to torture, while the group could not assure the news from other resources. It is noted that he is from Al Fida'ya lane in the Yarmouk camp, as the group documented the names of 295 Palestinian refugees who died due to torture in the Syrian prisons.

Recent Updates

More than 600 days of the strict siege imposed on the Yarmouk camp by the Syrian Regular Army and PFGC groups that besiege 20,000 civilians in the Yarmouk camp for Palestinian refugees in Damascus causing various health and living crises.

All hospitals and clinics stopped working except for Palestine hospital which provides simple medical services, the stop resulted in the acute shortage of medical staff and materials due to the siege, 683 days of power cut, and 173 days of water cut, in addition to the scarcity of fuel that is required to operate the generators.

In terms of living aspect, there are any main food supplies inside the camp; such as bread and rice and others, and in case small quantities is available by the greedy merchants, the one kilo of rice may reach 50\$. It is also mentioned that the regime and the PF checkpoints prevent the entry of urgent relief aid that was produced by some international organizations between now and then, three months ago.


In light of this tragic reality, the number of victims' siege, that was documented by the AGPS, still increasing till yesterday to reach 171 victims, the last one was the 20-day-enfant "Mohammed Jameil Al Assar who died yesterday due to the lack of medical care and the malnutrition inside the besieged camp.

On the other hand, the Syrian security forces at Homs still detaining three women and a young girl from Al Aedein camp in Homs after taking them as hostages to negotiate with relatives until they surrender themselves during a recent raid on the camp on 25th of last February.

Despite the fact that their relative and the young men who were with him had surrendered to the Syrian security who executed all of them after hours of being detained, and continues detaining the women till now, while their fate is still unknown until this moment.

It is noteworthy that the Syrian news agency of the Syrian regime published images of Palestinian refugees Wisam Al Sayed, Rami Subhia, Ahmed Al Saa'by, and Abdul RazakAmayri, who were executed in spite of being surrender to Syrian security authorities that carried out wide raid campaign at Al Aedein camp in Homs.

According to a previous testimony by one of the residents that the Syrian Security arrested Ramy Sabheyya, Wesam Al Sayyed, Ahmed Al Shabi and Abdel RaziqAmayeri after they were threatened with their families where they surrendered to the Syrian Security under the condition of not harming their families.

It is mentioned that the four refugees were amongst the residents who settled their positions in the camp 3 months ago within the agreement between the Syrian Security and the Militants and the Palestinian factions in the camp were the mediators in this agreement but the Syrian Security raided their houses and arrested them after they surrendered and executed them.

In a related context, the Syrian Security released the young man Mahmoud Khalid Mahmoud Shatara from Tarshiha village in Palestine. It is mentioned that Al Aedin camp in Homs witnesses security tensions due to the last raid that were carried out by the Syrian Security in the Camp.

The Vicinity of Khan Al Shieh camp in Damascus Suburb was exposed to explosive barrels yesterday that targeted the surrounding farms which led to the spread of worry and fear state in the camp due to it was close to the residents' houses. The roads that connect the camp with the city center are still closed except for Zakia Khan Al Shieh road.

In Germany, the Palestine League in Germany concluded the seminar activities of the Palestinians of Syria ...Nakba Renews Nakba. The seminar came to shed light on the humanitarian crises file of the Palestinians of Syria. The seminar was attended by the Palestinian and Arab organizations in Berlin and a number of the Palestine and Arab Communities in Germany.

Mr. Khalid Al Zaher, the head of the Palestine League in Germany, stressed on the necessity to end the siege that is imposed on the Palestinian camps in Syria and to stop bombing the camps. Mr. Al Zaher

mentioned the efforts of the Palestine League in Germany since the beginning of the crises on all levels; official and popular levels in order to alleviate the suffering of the besieged people in the Palestinian camps through Al Wafaa European campaign. Mr. Al Zaher stressed on the necessity to unite the efforts in order to end the suffering of the Palestinians of Syria and to work to merge them in the German society.

In his turn, Mr. Majed Al Zier, the Head of Palestinians of Europe Conference, assured on the need to continue the national Palestinian work where the Palestinian of Europe proved, during their activities and their interaction with the Palestinian crises, that they have their freedom project which is to return to the homeland and Jerusalem, moreover, they were able to attract the European public opinion to the suffering of the Palestinian people on all levels. Mr. Al Zier continued that the Palestinians of Europe Conference No 13 will host about 30 Palestinian personalities and will be held on 25th of April in the Berlin the Diaspora capital under the title of "Palestinians of Europe and the National Palestine Project"



The seminar activities "the Palestinians of Syria ... Nakba Renews Nakba"

Mr. TareqHamoud, the Executive Manager of the Palestine Return Center in London and the Founder Member of the AGPS, presented a detailed explanation about the crises of the Palestinians of Syria since the first day and introduced important statistics that sum up the suffering of the Palestinians of Syria. Mr. Hamoud added that it became unacceptable to mention the Palestinians of Syria case just in occasions but it has to be

the first priority for everyone. He also mentioned the suffering that the Palestinians of Syria are exposed to due to siege such as the social and psychological crises and put the responsibility on the attendance that they have to help the Palestinians of Syria in Europe in order to give them help and to let them know their rights so they can start a new life in Europe.

It is mentioned that the Palestine League in Europe determined certain time to host the Palestinian refugees in the league's headquarter in Berlin and will give them legal consultancies and help them to merge in the German society. On the other hand, some of the Palestinian organizations in Europe were invited to attend a workshop in Rotterdam in Netherland titled as "the Palestinians of Syria ... Chances and Challenges", where the participants discussed the situation of the Palestinian refugees in Syria in addition to the challenges that they face in Europe and the chances to serve their people specially the Palestinians of Syria.

Numbers and Statistics till 01/3/2015

- At least 27933 Palestinian Syrian refugees have reached Europe during the last 4 years.
- 2677 Palestinian Victims were documented by the AGPS
- The Yarmouk Camp: Siege, imposed by the Regular Army and PFGC, continued for 603 days respectively. In addition, power cuts continued for more than 683 days, water was cut for 173 days respectively. The number of victims due to the siege has reached to 171 victims.
- 80,000 Palestinian Syrian refugees escaped from Syria to the neighboring towns, including 10,687 refugees in Jordan, 51,300 in Lebanon and 6,000 refugees in Egypt, according to UNRWA statistics till February 2015.
- Al Husayneyya Camp: Regular Army is still preventing the residents of the camp to return back to their houses for 505 days respectively.
- Al Sheina Camp: Regular Army is still preventing the residents of the camp to return back to their houses for 474 days respectively.

- Handarat Camp: Residents have left the camp for 676 days after the Syrian Opposition Groups controlled it.
- Dara'a Camp: It is now almost 320 days without water and 70% of its buildings were demolished.
- Jermana, AL SaiedaZAinab, Al Raml, Al Aedein Camps in Homs and Hamma: A relatively quiet situation in light of the economic crises.
- Khan Al Sheih Camp: Roads linking the camp to the city center are still closed except for Zakia- Khan Al Sheih road.
