#### Lebanon

A Lebanese hospitals demanded 45,000 \$ in exchange for the release of the dead Palestinian Syrianrefugee "MunirMazen Saleh," who died following the recent clashes at Ein Al Hilwa camp.

Family of the young Palestinian Syrian launched an urgent appeal for intervention and action to take out the body of their son from the hospital that refused to hand him over before payment for treatment, which amounted to \$45,000.



It is noteworthy that his mother

had arrived from Syria to Lebanon after her son injury, and immediately after his death, she went to the hospital to receive the body and bury him. The mother was surprised by the high cost of treatment, that she cannot afford, as the hospital refused to deliver his body before payment, yet, the Red Cross helped her with 1500\$ only.

The family accused UNRWA of escaping responsibility, while UNRWA responded to the family: "Why did not you tell us that he is in the hospital?" according to the victim's relatives.

The young Palestinian Syrian victim had fled with his wife after targeting Yarmouk, while he was injured during clashes between Fatah and Jund al-Sham at Ein Al-Hilwa camp. A bulletentered his shoulder penetrated his right lung and settled his left lung.

He was transferred to Labib Abu Dahr hospital in Sidon on 22.08.2015 and he was conducted to on automatic breathing apparatus, and then he had a surgery without improvement, as he died on 01/09/2015.

#### Recent Updates

The day before, Mr. Adnan Ibrahim, Mr. Mohammed Elayyan entered the besieged Yarmouk camp to meet with representatives from Al Nusra Front Abu Hasan Jebha and Abu Ali Al Saedi, and representatives from AL Hiwar committee in the camp Abu Ahmed Hawwari, Head of the Palestinian National Commission, Basel Ayyoub, the head of Yarmouk Relief Office, and Abu Al Majd Taha, Fateh movement representative in the camp.

The meeting came through the continuous efforts to solve the stuck points to implement the neutralization of the camp. Moreover, positive attitudes prevailed the meeting.



The Regular Army and the PFGC still impose siege on the Yarmouk camp for 793 days respectively, cut the power for 863 days and water for 353 days respectively. Al Nusra Front and ISIS are still controlling 60% of the besieged camp.

On the other hand, the eastern parts of Khan AL Shieh camp for Palestinian refugees in Damascus suburb were exposed to bombing, where a mortar shell at least targeted near the river in the eastern side of the camp. The Regular Army checkpoints still close all roads that connect the camp with the city center which prompted the residents to go through Zakia-Khan Al Sheih road despite the big risky, where the road is being targeted by frequent bombing and clashes by the Regular Army forces in the adjacent areas.

#### **AGPS Statistics**

The statistics on the AGPS website" www.actionpal.org.uk" refer to that bombing is in the first place for the reasons of death that led to victims amongst the Palestinian refugees in Syria, where bombing led to the death of 1043 victims.

Clashes came in the second place where it caused the death of 652 victims. Torture to death in the Syrian detention came in the third place where 414 Palestinians died due to torture in the Syrian prisons. The total number for the Palestinian victims that were documented by the AGPS reached more than 3000 victims, which were documented with name, place and reason of death.

#### Civil Work Committees

The Palestine Charity continues its relief work for the residents of Yarmouk camp; the services include the Yarmouk residents who are registered in the records of the Palestine charity.

The residents of Yarmouk that the Palestine Charity serves are Palestinians, Syrians, and Iraqis but they should prove that they are from the residents of Yarmouk, where the relief office give monthly sponsorships for 834 families which are about 1916 individual. The Palestine Charity said that it will continue till the end of December 2015 with the possibility to continue to the next year, where the cases will be evaluated and studied by the relief committee in the Palestine Charity.



It is referred that Yarmouk camp residents inside the camp suffer of the continuous siege which prevent the entry of food and medical materials. The displaced of the camp suffer from the weak financial resources and the spread of unemployment in addition to the continuous worry due to the arrest campaigns which prompted them to take cruel choices that are dangerous to their children and their lives such as migration.

#### Numbers and Statistics till 3/9/2015

- 15,500 Palestinian Syrian refugees in Jordan, 45,000 Palestinian Syrian refugees in Lebanon, and 6,000 refugees in Egypt, according to the UNRWA's statistics till July 2015.
- At least 36,000 Palestinian Syrian refugees have reached Europe during the last 4 years.
- The Yarmouk Camp: Siege, imposed by the Regular Army and PFGC, continued for 793 days respectively. In addition, power cuts continued for more than 863 days, water was cut for 353 days respectively. The number of victims due to the siege has reached to 180 victims.
- Al Sbeina Camp: Regular Army is still preventing the residents of the camp to return back to their houses for 655 days respectively.
- Handarat Camp: Residents have left the camp for 856 days after the Syrian Opposition Groups controlled it.
- Dara'a Camp: It is now almost 500 days without water and 70% of its buildings were demolished.
