
"A Number of Embryonic Deformities in Yarmouk and South Area in Damascus"

Recent Updates

Medical Corps in the south of Damascus documented three cases this year of deformed embryos in the southern region; the last one was from Yarmouk camp in Damascus.



The agency said that over the past month it has documented (10) abortion cases in the southern region, while the reasons attributed to a number of factors namely malnutrition and fear of bombing and explosive barrels.

Meanwhile, the Yarmouk refugee camp witnessed yesterday sniper exchanged between opposition groups in the town of Yalda and Alnusra alongside ISIS. Snipping resulted in the injury of the Palestinian refugee "Maher Shihabi" in the Yarmouk refugee camp, and two injuries in the town of Yalda, followed by closure of the crossing border, which links between the neighboring Yalda and Yarmouk.

It is noteworthy that the road between the Yarmouk camp and Yalda is the only port that connects between families of the Palestinian refugee and the towns of Babbila, Yalda, and Beit Sahem, while food and medical aid enters through it.

The regular army and PFGC groups impose a strict siege on the Yarmouk refugee camp for more than (795) days, which exacerbating

health and living conditions in the camp, especially after the storming of ISIS early last April.

On the other hand, the Syrian security forces continue to detain more than (966) Palestinian Syrian refugees, including children, women, elderly, brothers, fathers, sons, young people, and entire families, while hundreds of them died due to torture.

Detainees distribute on all areas of the Syrian and refugee camps, where the largest number of detainees at Al Aedein camp. 179 detainees were documented; 126 in the Yarmouk refugee camp, 98 in Khan Al Shieh camp in Damascus suburb, 83 in Neirab camp in Aleppo, 78 in Alraml camp in Latakia, and 52 in Al Aedein camp in Hama.


Meanwhile, dozens of refugees were distributed in the rest camps, yet the Syrian security services still vague about their fate, as well as their families for fear of their lives.

The detainees were subjected to all kinds of torture, which killed 414 Palestinian refugees, (77) of them were identified through the leaked images of torture victims.

It is worth mentioning that testimonies of released detainees from Syrian prisons confirm the presence of babies at the Syrian security branches.

Lebanon

The Palestinian Organization for Human Rights 'PHRO' confirmed, in an appeal considered as a notification for the Public Prosecution Discriminatory in Lebanon, the intersection of a number of information

and complaints about armed professional robbery gangs who exploit the vulnerability position of Palestinian and Syrian refugees from Syria, and

robbing on their way to travel or to carry out official transactions, after traveling in small buses (vans).

Pointing out that reasons for the growth of this phenomenon related to the fear of refugees



from Syria, and especially the Palestinian refugees, from detention if they complain against the police stations due to not having residency by public security.

In addition, refugees fear of the possibility if those gangs knew and abuse them if they complain, especially when the looting taking place in the area between the Kuwaiti Embassy roundabout and the southern suburbs, because they will have to make a complaint at the police station located inside the southern suburbs.

The organization noting that failure to resolve the situation of refugees from Syria in general, and the Palestinian refugees from Syria in particular, in terms of giving them the right to reside as refugees from a war zone, as provided by international humanitarian law, make them in a vulnerability position and vulnerable to exploitation and permanent fear, which would forces them to stop heading to the Lebanese official authorities with jurisdiction: judicial and / or security, which helps these gangs in impunity.

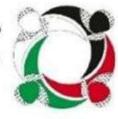
The human rights organization stresses on the fear that there will be cases of harassment or sexual abuse or rape against girls and women, by those gangs, asserting that the robbed girls and women stop filing complaints at the official authorities, or in front of human rights and civic organizations not only for fear of those gangs to know their complaints, but because of social traditions and customs, and ashamed to talk about their experiences.

The organization concludes its statement inviting the security authorities to immediately intervene to prosecute the perpetrators of looting, stressing the need to settle the legal status of refugees across to recognize them as refugees and their right to gain legitimate residency, without incapacitating conditions contrary to the nature of their status as refugees, which contributes to the reduction of vulnerability process.

The organization also called the international community to open the way for refugees from Syria, and the Palestinians of them, especially because of the compound that suffer from vulnerability, to move to a second country that provides them protection and all refugees' requirements.

Asylum News

The Hungarian authorities allowed, yesterday morning, hundreds of Palestinian and Syrian refugees to access Germany and Austria, through dozens of buses.

According to activists, the Hungarian authorities did so after pressure and talks took place between the three countries Germany, Austria, and Hungary.



It is worth mentioning that thousands of Palestinian and Syrian refugees are still trapped in the Hungarian territory, in the context of trying to reach northern Europe to escape the war in Syria.

On a related context, Slovak authorities released two young men "Basil, and Khaled Shankal" after being detained for about two months and a half, while passing by their lands on their way to northern Europe.

Numbers and Statistics till 5/9/2015

- 15,500 Palestinian Syrian refugees in Jordan, 45,000 Palestinian Syrian refugees in Lebanon, and 6,000 refugees in Egypt, according to the UNRWA's statistics till July 2015.
- At least 36,000 Palestinian Syrian refugees have reached Europe during the last 4 years.
- The Yarmouk Camp: Siege, imposed by the Regular Army and PFGC, continued for 795 days respectively. In addition, power cuts continued for more than 865 days, water was cut for 355 days respectively. The number of victims due to the siege has reached to 180 victims.
- Al Sbeina Camp: Regular Army is still preventing the residents of the camp to return back to their houses for 657 days respectively.
- Handarat Camp: Residents have left the camp for 858 days after the Syrian Opposition Groups controlled it.
- Dara'a Camp: It is now almost 502 days without water and 70% of its buildings were demolished.
- Jarmana, AL Saieda ZAinab, Al Raml, Al Aedein Camps in Homs and Hamma: A relatively quiet situation in light of the economic crises.
- Khan Al Sheih Camp: Roads linking the camp to the city center are still closed except for Zakia- Khan Al Shieh road.
