Victims

The Colonel, "Khaled al-Hassan" died during facing the attacks of ISIS groups against the Yarmouk Camp. It is mentioned that he was dissented

from the PLA and founded AhrarJaishAl Tahrir group with a number of young people. The young man "Mohamed Ibrahim Mawed" died due to a previous injury following the bombardment of the camp. Meanwhile, the Palestinian refugee "Amer Rashid" died due to earlier clashes broke out in the vicinity of Palestine

Hospitalat Yarmouk, during his attempt to face ISIS and AL Nusra Front attacks. The pro-Syrian Regime groups announced the death of "Ahmed Waleid Al Bulad" following the clashes in the Yarmouk camp.

"Mohammed Ghazi Al-Saadi" a PLA officer in Adra Industrial Area at Damascus suburb due to the clashes between the Syrian army alongside with the PLA groups and the Syrian armed opposition.

Recent Updates in the Yarmouk Camp

United Nations Security Council on Monday demanded to allow humanitarian aid to enter the Yarmouk Palestinian refugee camp, where

ISIS groups control large parts of it, amid Palestinian warning of "genocide," and deterioration in the humanitarian situation.

The Council called, in an emergency session to discuss the situation in the Yarmouk refugee camp, to protect civilians and ensure humanitarian aid access, including the necessary life-saving assistance, "according to the Ambassador of Jordan at the Security Council Dina Kawar, whichher countryheadsthe Council this month."

The UN warned of a "terrible" humanitarian attitude for about 18 thousand Palestinians, including 3,500 besieged children inside the camp.

On the same context, heavy shelling targeted the Yarmouk camp

yesterday, where huge explosions rocked different parts of it, causing huge material damage with no news about injuries.

Sporadic clashes broke out between the Aknaf brigades and ISIS groups who broke into the camp (6) days ago, without changing areas controlled by each of them, where ISIS groups are still control (80%) of the camp.

In terms of the human side, medical

situation continu eto deteriorate, where treatment is not available for dozens of wounded due to running out of medical supplies from inside the camp, and under the tension conditions in the camp were (975) family

from the Yarmouk camp were displaced where they are currently in the nearby town of Beit Sahem.

Interaction with the Yarmouk Refugee Camp

During his participation at the seminar of Palestinian refugees and the protection demands, which was held by PRC in the Lebanese city of Tripoli, the AGPS member "Maher Shaweish" called all conflict parties to expedite the convening of a humanitarian truce, calling to open a passage for the relief of civilians with international guarantees supervised by the International Red Cross and UNRWA, stressing the need to neutralize the Palestinians of the internal conflict, stressing that the refugees in Syria are guests and it is necessary for them to maintain their camps as the title to the right of return.

For his part, the regional coordinator for the Palestinian Return Centre in the Arab region "Ali Huwaidi" stressed the need for "UNRWA" to expand its policies, including the physical protection for refugees, calling

to take advantage of membership "observer" to the State of Palestine to the United Nations to coordinate with states Members.

Moreover, the Palestinian institution for human rights "Shahid", issued a statement addressed the deteriorated medical situation in the Yarmouk camp, confirming that the inaction of protecting the Palestinian refugees in the Yarmouk camp will accelerate the termination of their presence in Syria.

The statement emphasized that the Palestinian presence in Syria has become endangered, and the failure to protect the people of the Yarmouk camp will accelerate ending the issue of Palestinian refugees in the diaspora, particularly in Syria, while the statement concluded by calling for neutralizing civilians and respect the rules of war in local conflicts, particularly Additional Protocol II to The four Geneva agreements of 1949, calling for the Syrian government to the need to open ports to enter the humanitarian relief assistance to the civilians.

The statement called all non-Palestinian armed groupsto leave the Yarmouk refugee camp, and to avoid the Palestinian refugee camps for the furnace of the conflict in Syria. In addition, Yarmouk camp or any other camp should not be an anchor for attacks against the Syrian government forces, and that the UNRWA to take more dynamic and effective role in order to help Palestinian refugees in Yarmouk.

The statement also stressed the need to have an effective international action through the International Committee of the Red Cross and other international organizations, and the PLO to assume its national serious

role toward the Palestinian refugee camps in general and the Yarmouk refugee camp in particular, and to declare the national emergency.

The Palestinian and national factions called for united actions to neutralize the Yarmouk camp, warning of continued violating towards the Palestinians in Syria, according to a statement issued after a meeting at the headquarters Islamic Jihad Movement in Gaza to discuss the events and developments in the Yarmouk refugee camp in the Syrian capital of Damascus.

The national forces demanded all conflict parties in Syria to spare the Palestinians the ravages of internal conflict, stressing that the blood of our people will not be cheap in any way, calling for immediate withdrawal and the release of detainees and kidnapped people as soon as possible.

The United Nations, the international community, and all its institutions also called to do its part to stop the suffering of the camp massacres, stressing that the only way to save our people is the establishment of an independent Palestinian state with Jerusalem as its capital and the return of refugees to their homes.

In the same context, the Arab League demanded the international community to intervene immediately to ensure not involving the Yarmouk and the Palestinian refugee camps in the ongoing conflict in Syria without the well of the inhabitants and completely neutralize them the scourge of the clashes.

The Arab League said in a statement issued by the Palestine and the occupied Arab territories sector, that they follow-up with anxiety and

anticipation of serious conditions and deteriorating suffered by the Palestinian refugees in Syria, who are estimated with more than 500 thousand Palestinian refugees in light of the humanitarian attacks against them because of their involvement in the conflict, which increased blatantly recently following the groups that broke into the Yarmouk refugee camp during the past two days and turned it into a war zone, causing a humanitarian catastrophe.



On the other hand, solidarity vigils toke place in Jerusalem, the Gaza Strip, Nablus, Nahr Al Barid camp, the German capital of Berlin, and the Swedish city of Malmo to show solidarity with their besieged families in the Yarmouk refugee camp, and who are exposing to violent bombardment by air and ground attack from ISIS.

The participants demanded the Palestinian, the international institutions, human rights organizations, the RCIC committees, and UNRWA for urgent action to put an end to the suffering of the people of the Yarmouk refugee camp, to end their siege, to stop the bombing, and to introduce emergency medical assistance to treat the wounded people.

Civil Work Committees

Al Wafaa European campaign launched an urgent campaign in order to relief families and children in the Yarmouk refugee camp as well as the besieged families following the intensification of the fighting and shelling following the entry of the ISIS into the camp.

The campaign demanded all armed parties in the Yarmouk refugee camp to the need for immediate and rapid action to spare the civilians the

fighting inside the besieged camp, warning of a potential humanitarian disaster if the situation continues as it is, especially after the entry of ISIS to the



camp and imposed control over the camp last Wednesday.

The campaign also appealed all international organizations and relief and medicalinstitutions for urgent action within the Yarmouk refugee

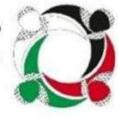

camp for the relief of 20,000besieged people inside the camp, including 3,500 children, after the cessation of all medical points inside the camp for work, and the targeting of the only hospital that was working inside the camp with the efforts of individual voluntary.

Numbers and Statistics till 6/4/2015:-

- At least 27933 Palestinian Syrian refugees have reached Europe during the last 4 years.
- The Yarmouk Camp: Siege, imposed by the Regular Army and PFGC, continued for 639 days respectively. In addition, power cuts continued for more than 719 days, water was cut for 209 days respectively. The number of victims due to the siege has reached to 173 victims.
- 80,000 Palestinian Syrian refugees escaped from Syria to the neighboring towns, including 10,687 refugees in Jordan, 51,300 in Lebanon and 6,000 refugees in Egypt, according to UNRWA statistics till February 2015.
- Al Husayneyya Camp: Regular Army is still preventing the residents of the camp to return back to their houses for 540 days respectively.
- Al Sheina Camp: Regular Army is still preventing the residents of the camp to return back to their houses for 510 days respectively.
- Handarat Camp: Residents have left the camp for 712 days after the Syrian Opposition Groups controlled it.

- Dara'a Camp: It is now almost 355 days without water and 70% of its buildings were demolished.
- Jermana, AL SaiedaZAinab, Al Raml, Al Aedein Camps in Homs and Hamma: A relatively quiet situation in light of the economic crises.
- Khan Al Sheih Camp: Roads linking the camp to the city center are still closed except for Zakia- Khan Al Sheih road.
