"The First Group of Nusra Leaves Yarmouk to Idlib within the Four Towns Agreement"

Victims

The two Palestinians "Zuhair Hussein Alkamel" and "Abdulkareim Muhannad Abdo" died while fighting in Syria. Al Jalil forces, one of the pro-Syrian regime military groups, said that they were killed while fighting in the villages of Hama and Deir al-Zour.

Al Jalil forces, the military wing of Shabab Alawda Movement, is considered as a military formation that fights alongside the Syrian Regime, while a number of the Palestinian factions have formed armed groups fighting alongside the Syrian regime, deployed in and around some Palestinian camps and sometimes engaged in battles in support of the regular army.

Recent Updates

The AGPS correspondent reported the start of the evacuation of the injuries of the Sham Liberation and their families from the Yarmouk camp south of the Syrian capital Damascus to the city of Idlib in northern Syria,

Pointing out that several buses belonging to the Syrian Red Cross entered areas controlled by Sham Liberation in the Yarmouk camp to transport the injuries to Idlib.

For its part, media sources of the regime confirmed that the evacuation of injuries has already begun yesterday, confirming that this step comes within the completion of the implementation of the terms of what is known

as the four cities agreement signed between the "army of Fatah" on the one hand and the Syrian regime and the Iranian side on the other.

The Sham Liberation Organization controls the area from Al-Habib Al-Mustafa Mosque to Al-Wasim Mosque, while ISIS controls the rest of the camp.



The AGPS correspondent in Yarmouk reported that fighting between ISIS and the "Sham Liberation Organization" is witnessing an intensive deployment of ISIS members, fortifications, and lifting of earth mounds, after the start of evacuating injured fighters of the Sham Liberation Organization towards Idlib.

The AGPS correspondent in Yarmouk camp confirmed that ISIS terrorized the remaining Palestinian families inside the camp, where it carried out several public whipping and defamation of many residents after being accused of doing drugs.

It is noteworthy that ISIS had taken control of the Yarmouk camp in coordination and cooperation with members of Nura, where it imposed

control over large areas of the camp after fierce battles with the Syrian armed opposition groups early April 2015.



Meanwhile, serious diseases spread in the southern region of the capital Damascus - Yalda, Babila, and Beit Samah, and affected children such as acute diarrhea and inflammation of the intestines and other diseases were diagnosed.

For his part, the AGPS correspondent south of the capital Damascus confirmed that high degrees of disease and epidemics began to spread among civilians and hundreds of Palestinians in Yarmouk camp because of drinking water wells and contaminated water that do not meet the specifications of health.

It is noteworthy that the Syrian regime continues to cut water from Yarmouk camp and its surroundings, in addition to the suspension of springs that feed the capital and its surroundings because of the bombing.

Civil Work Committees

In cooperation with Shorouk Al-Shams Foundation, the Palestine Charity Committee distributed money to 500 orphans Muzareeb southern Syria on Sunday, 7\5\2017, at the Authority's headquarters, where a sum of \$2,500 was distributed.

This comes within the framework of the Committee's efforts in an attempt to alleviate the suffering of Palestinian refugees in southern Syria who complain about the absence of international and official relief institutions.

Palestinians of Syria; Numbers and Statistics until 08\05\2017

- The AGPS documented 3489 Palestinian victims, including 455 women.
- 1189 Palestinians are detained in the Syrian regime intelligence and security branches, including 87 women.
- The Regular Army and the PF-GC groups are besieging the Yarmouk camp for 1390 consecutive days.

- 1955 male and female Palestinian refugees died due to the lack of nutrition and medical care because of the siege; most of them are from the Yarmouk Camp.
- It is now more than 1121 days without water in Deraa camp, and 972 days in the Yarmouk camp.
- Residents of Handarat camp are prevented from returning to their houses for 1464 ° days, while the camp is controlled by the Regular Army for more than 19 ° days.
- Almost 85,000 Palestinian Syrian refugees have reached Europe till the end of 2016, while the number of Palestinian refugees in Lebanon is almost 31,000, in Jordan 17,000, in Egypt 6000, in turkey 8000, and in Gaza 1000.
