
The refugee "Yousif Ahmed Abu Khadra" on Hunger Strike

#### Turkey- Kilice

The Palestinian refugee "Yousif Ahmed Abu Khadra" 24 years from Daraa camp started a hunger strike to protest against the miserable living conditions they suffer in Killce shelter center on the Syrian Turkish boarders. which contains 95 Palestinian Syrian Abu Khadra expressed his suffering, he said. "Like hundreds of Palestinian refugees in Syria, I had to leave Daraa camp after the deterioration of the security situation and after being shelled, and after a difficult journey, I arrived at Kilice center in Turkey and I was hoping to have security and be safe, but I was shocked like all the families in the bad services and medical care.

He added that he had heart surgery and was in desperate need of medication that he had received only after seven days and was also need (12 inflammation needle) but he had only three of them, and continued his speech "when I checked interested parties they evaded the answer and said that there is an amount sum of money for medical but not sufficient for all patients at the center of Kilis.

"Abu Khadra" called all the media, particularly AL Jazeera Channel, to visit the center and get acquainted with the conditions of the center and its services, especially after the tents flood two days ago with rainwater resulting in the injury of a number of children due to rain and biting cold. In the same context, fourteen Palestinian Syrian families slept yesterday in the open at the Turkish city of Kilis after the people who paying their rents abandonment them, it is mentions that there are thirty-four families live in the city of Kilis outside the shelter and a number of people paying the rents of their homes.

#### **Recent Updates**

A state of panic and horror experienced by the residents of the Yarmouk camp after hearing the sound of a huge explosion that rocked the camp, turned out to be a result of the bombing of a building in Palestine Street near AL Khayam Institute by the regime forces based in the municipality of Yarmouk, which led to physical damages to the adjacent buildings and the Internet and communications lines cut.

The people of the Yarmouk camp were targeted to shooting while they were waiting to receive relief baskets provided by UNRWA, while the water is still cut from all the houses of the camp since 08/09/2014 which resulted in, according to a statement one of the medical staff inside the camp, the spread of disease infectious and some cases of poisoning and diarrhea, skin diseases, and the return of some communicable diseases and chronic that the medical staff recently was able dispose, such as meat Typhoid and hepatitis, where he confirmed that these diseases spread because the residents are drinking from the artesian water wells which is not suitable for drinking.



In a related context, the committees and commissions in the Yarmouk camp work very hard to secure drinking water for the residents through reaching water to the houses by using the mobile water tanks, despite the suffering of the high cost of fuel because of the siege which is imposed on the camp by the Regular army and the PFGC for the 437 days respectively. The Regular army and the PFGC prevent the entry and the exit of residents and also it prevents the food supplies, medicine and fuel to be in.

In the same context, Dara'a Palestinian camp's residents complain of the water cut for the fifth month respectively which forces the residents to walk long distance to bring drinking water which expose them to danger because of the spread of snipers on the buildings that look on the camp's streets.

In Al Nairab camp the maintenance team in the camp fixed the water network in the surrounding areas. It has been waiting for the water to reach the residents houses in the coming 48 hours who were deprived for more than a year. The residents still suffer of the power cut on the camp since 13/1/2013 which obliged them to share electricity generators to lighten their houses and shops.

#### Release

Shady Abdulhaq 37 years old from Al Nairab camp, was released afetre being arrested for more than two months, it is refered that Abdulhaq works as a UNRWA school teacher.

#### **Cyprus**

A number of the Palestinians of Syria and the Syrians, who were rescued by the Cyprus coast Guards in 26/9/2014 and they were put in one of the refugees camps, delivered a message to the Cypriot authorities to allow them to leave its territory and to continue to the European countries which was the target from the beginning, they also appealed the United Nations and the High Commissioner and all international organizations to help them to achieve their goal to reach the European countries and to reunite with their families.

In the same context, the Palestinian Ministry of Foreign Affairs released that The Cypriot authorities have successfully conducted a rescue operation of 345 people, among them 52 children, 93 women and 200 men that were on board of a fishing vessel that was derailed due to strong winds and rough seas off the coast of Cyprus, and were in a lifethreatening situation. According to initial information, the passengers of the vessel; most of them Palestinian-Syrians (about 70%) and the rest Syrians, are in a good health condition, and there are no casualties.

On the other hand, on 6/9/2014, The victims' families issued a statement to condemn the European countries, Italy, Malta and Greece, decision of not sending any ship for the recovery of the bodies of refugees who drowned trying to make the crossing, and justified it as the ship was sank in the international water out of its regional water. According to the statement, those countries' excuses were the high coast of the search operations.

The families demand Mr. Mahmoud Abbas the Palestinian Presidents to interfere and put pressure on union countries to send teams to search the place of the drawn ship and to find the bodies of the drawn people, moreover, the families demand to open an investigation file to discover the reasons for the sinking ship and to raise a case on the causative people. At the end of the statement, the families stressed on that they will continue escalating their steps in the coming days through demonstrations and knocking all doors, human rights committees and the international organizations to release their destiny.
