Victims

The A Palestinian refugee, Ahmed Mugbel, from Khan Al Sheikh Camp in Damascus suburb died due to torture in the prisons of the Syrian Regime, raising the toll of torture victims to 386 victims according to the AGPS documented statistics.

Recent Updates

Number of shells and shelling targeted the Yarmouk camp south of the capital Damascus, which resulted in fires in some buildings overlook the Yarmouk main street, and caused only material damages.

Meanwhile, violent clashes broke out between the Syrian Army alongside the Palestinian groups and ISIS alongside AL Nusra Front at the Yarmouk Street, Thalathein Street, and the Vicinity of Yarmouk Girls High School.

In terms of living aspect, the remained residents of Yarmouk are suffering of tragic humanitarian conditions due to the lack of nutrition, medications, and medical supplies. In addition, the water still cut for all houses and lanes of the camp for almost 241 days, and power cut for 751 consecutive days.

In the meantime, residents of Al Raml camp in Lathakeia are living a state of calmness amid their continuous economic crisis, where they are complaining of the high prices of food supplies, and the high rents of houses. It was mentioned that the camp is receiving tens of families from other camps which suffered of shelling and siege.

United Arab Emirates

The AGPS received news about the UAE authorities decision to forcibly deport the Palestinian refugees "Wael Al-Sahli" (41) years, and his son, "Montasser Al-Sahli" (8) years to Syria, on the pretext of their entry into its territory with irregular visa. Within a voice message broadcasted on Facebook, "Wael Al-Sahli" stressed that he left Jordan on 30th of April through Dubai Airport to Libya to ride the boats of death in order to migrate to European countries to find safety and security, and a decent life. Upon the arrival of Wael and his son to Sudan, they were deported twice from Khartoum airport to Dubai Airport, which connected with a number of countries in order to receive him, but those countries refused to receive him and his son, forcing Dubai Airport management to consider a way to deportation to Syria, and that after ten days of their suffering at Dubai airport.


Accordingly, the refugee "Wael Al-Sahli" appealed, through the AGPS, all human rights, and civil work organizations to intervene to solve the crisis and not to deport them to Syria, which may put them at risk.

In turn, the AGPS demanded the UAE authorities to deal with them as refugees have rights guaranteed by international law, as it appealed the airport authorities in the United Arab Emirates in order to facilitate their affairs after their displacement from war zones in Syria.

Detainees

Syrian security services continue to arrest ten Palestinian refugees from one family since 12-6-2013. They are:

Mahira Mohammed Amayri, Hadeel Mahmoud Amayri, Aseel Mahmoud Amayri, Dawoud Mahmoud Amayri, Razan Mahmoud Amayri, Suhair Mahmoud Amayri, Maysa Jamal Idris, Firas Walid Desouki and his children Hamza Firas Desouki, and Hala Firas Desouki. They were arrested by members of Nisreen Street checkpoint at Al Tadamon neighborhood.

Meanwhile, the family of the Palestinian detainee "Mohammed Mahmoud Masharqa and a group of activists appealed the concerned bodies, institutions, and the PLO to work to release the detainee Mohammed Masharqa from the Syrian prisons, after more than 7 years of detention without any charge s. Masharqa was detained for 11 years in the prisons of the Zionist occupation. After he was released from Israeli jails, he resorted to Syria where was arrested, and has not been released due to lack of evidence.

Civil Work Committees

The Charity Committee for the Relief of Palestinian People, in cooperation with the international Relief Ageny, distributed food aids to the Palestinian refugees in Khan Al Shieh, Sehnaia, Kherbat Al Sheiab, and Khan Dannon camp in Damascus suburb.



Egypt

Egyptian authorities continue detaining number of Palestinian Syrian refugees, despite the conversion of their charge made by the Public Prosecution of entering the country illegally, to refugees of war. 56 Palestinian refugees are still detained by the Egyptian authorities, after

being detained while trying to reach Italy from Turkish beaches on 1/25/2015. The refugees were victims to a scam by smugglers who left them on one of the islands off the Egyptian beaches, where the Egyptian authorities arrested them. It is noteworthy that Egyptian security released all Syrian detainees while continued detaining 56 Palestinians, after all the surrounding countries refused to receive them. The detained refugees were asked to choose either to be deported to Syria or to stay in prison.

Boats of Death

A group of Palestinian and Syrian immigrants appealed International and the Italian Red Cross to intervene in order to secure them across to Italy, after a strike on a commercial ship that has been rescued and headed to Greece, rejecting the Greek police attempts to forcibly disembark them to Greece.



Migrants also called news Arab, international, and Greek agencies to go to port of Kalamata to transfer their suffering and their strike on board the merchant ship to put pressure on the Greek and the Italian Red Cross to coordinate in order to transfer them to Italy.


The boat was that was carrying Palestinian and Syrian immigrants which launched from Turkey to Italy, was out of fuel while merchant ship was headed to Greece rescued them. The Greek police tried to climb the vessel to force the immigrants to disembark, but the ship's crew refused to do so without the presence of the Red Cross.

Greece is one of the countries which illegal immigrants feared to reach, while Greece is known as the tomb of immigrants, because of the difficult living conditions between detention in prisons and the government's refusal to give them immigration documents, as well as hostility neo-Nazis to them, and violations of police for the most basic rights of migrants in the prisons.

Numbers and Statistics till 9/5/2015:-

- At least 27933 Palestinian Syrian refugees have reached Europe during the last 4 years.
- The Yarmouk Camp: Siege, imposed by the Regular Army and PFGC, continued for 681 days respectively. In addition, power cuts continued for more than 751 days, water was cut for 241 days respectively. The number of victims due to the siege has reached to 177 victims.
- 80,000 Palestinian Syrian refugees escaped from Syria to the neighboring towns, including 10,687 refugees in Jordan, 51,300 in Lebanon and 6,000 refugees in Egypt, according to UNRWA statistics till February 2015.

- Al Husayneyya Camp: Regular Army is still preventing the residents of the camp to return back to their houses for 562 days respectively.
- Al Sbeina Camp: Regular Army is still preventing the residents of the camp to return back to their houses for 543 days respectively.
- Handarat Camp: Residents have left the camp for 745 days after the Syrian Opposition Groups controlled it.
- Dara'a Camp: It is now almost 388 days without water and 70% of its buildings were demolished.
- Jermana, AL Saieda ZAinab, Al Raml, Al Aedein Camps in Homs and Hamma: - A relatively quiet situation in light of the economic crises.
- Khan Al Sheih Camp: Roads linking the camp to the city center are still closed except for Zakia- Khan Al Sheih road.
