


The effects of the explosive barrels on the refugee camp of Khan Sheikh

Recent Updates in Syria

Explosive barrels targeted Khan Al Sheih camp in Damascus city resulted in significant damage to civilian homes and shops, while the camp and the surrounding areas have witnessed an escalation of military actions during the past few months.

Dara'a camp south Syria was hit by violent explosive barrels as well, resulting in one victim and a number of wounded in addition to the great destruction in the camp neighborhoods. Dara'a camp have been recently bombed repeatedly with mortars and artillery, which led to the destruction of large parts of it, In addition to the displacement of hundreds of family to the neighboring towns.

Alnairab the Palestinian refugee camp in Aleppo was hit by one of the homemade rockets which hit Palestine mosque causing material

damages, as violent explosions were heard resulting from the bombing targeted Alnairab military airport near the camp.

Widespread arrests campaign in Al A'edein camp at Homs included gas distribution centers, bread distribution centers and some of the markets; the detainees include two brothers, in the third decade "Mohammed Hussein Fidda" and "Ahmed Hussein Fidda", from Al Bassa village in Palestine.

Meanwhile in Damascus city the water crises still continue in Khan Dannoun camp, due to the interruption of the main line feeding water coming from the area," Deir Ali "amid reports talk about members of the People's Committees affiliated to the Regular Army cut off the water, on the security aspect, the camp witnesses a state of careful calm.

Lebanon

The Human Development Center called Lebanese state to take necessary actions and facilities to ensure that Palestinian Syrian students doing exams in Lebanon and Syria. The center calls for each of UNRWA and the PLO to take full responsibility towards the Palestinian students refugees and find appropriate and fast solutions to save the school year.

Hundreds of Palestinians of Syria students still threatened with the loss of their academic year, due to the decision to prevent the entry of

Palestinian refugees from Syria to Lebanon, and the consequent problems and Legal crisis. The Palestinian Syrian students live a state of fear and anxiety because of their inability to return to join the refugee families in Lebanon if left to provide the public examinations in Syria.

The Centre indicated that the human rights system provides the importance of education issues in Article 26 of the Universal Declaration of Human Rights, which insured that every person has the right to educate, as well as the International Institute for Economic, Social and Cultural Rights in Article 13, 14 and 15 also mentioned the education issues, noting that Lebanese recent decisions contradict with human rights standards that are set in the agreements and international conventions, as incompatible with the introduction of the Lebanese Constitution, which states respect to human rights.

On the other hand, UNRWA has announced its intention to update the data of Palestinian refugees who live in Lebanon, through field visits to their homes, UNRWA declared in a statement, which the Action Group have a copy of it, "they will start by calling the families of Palestinian refugees from Syria starting from Tuesday 10th June 2014. Field visits suppose to begin on Thursday, 12th June 2014 as part of the updating process.

UNRWA called families that have not been visited or accessed to Contact their centers and update their information on June 30th until July 4th, confirmed at the end of its statement that it will conduct home visits in all regions in Lebanon's Palestinian refugee camps inside and outside.

In a related context "UNRWA" announced that 76000 Palestinian refugees from Syria left Syrian territory because of the recent events to other countries, representing 15% of the total number amounting to about 440000 refugees, according to UNRWA, as the report pointed out that the number of refugees who have changed places of residence within Syria exceeded 194 000 refugees, which is 37% of the total number of Palestinians. While the report didn't refer to the states that Palestinians of Syria immigrated to.
