Victims

The Palestinian refugee "Rida Hassib Al-Masri" died while he was participating in the conflict in Syria. The Fatah Intifada movement, one of the pro-Syrian Regime Palestinian factions, declared his death and said that he is from the Yarmouk Camp and died at Maliha area in Damascus suburb.

Raising the number of Palestinian refugees who have died due to gunshot since the beginning of the outbreak of war in Syria to 870 victims, according to the documented statistics of the Action Group for Palestinians of Syria.



Recent Updates

A large state of resentment among the Palestinian refugees in the Palestinian camps and compounds in and outside of Syria after the new victims of the PLA in Syria. The PLA death toll rose to 201 victims since the war started in Syria.

The Palestine Liberation Army declared the killing of five members in Damascus suburb two days ago, where the Palestine Liberation Army

and the Syrian regime are participating in clashes against the armed opposition groups.

The families of the Palestinian victims accused the leadership of the Palestine Liberation Army, led by its chief of staff, Tariq al-Khadraa, of bringing their children into the conflict in Syria and shedding the blood of the Palestinian youth in a battle that is not their battle and sending them away from Palestinian camps.

It should be noted that the Palestinian refugees in Syria are obliged to serve in the PLA army, and all those who failed to join will be facing prosecution and imprisonment.



An Austrian court sentenced the Palestinian Syrian refugee (B-B), from Al-Aedein camp in Homs, imprisonment for life in charges of committing war crimes in Syria.

According to the BBC, Austria issued the first sentence on charges of war crimes in Syria against a Palestinian Syrian young man, a member of the Faruq battalion of the armed groups "Free Army" which is opposes the

Syrian regime. He was sentenced to life imprisonment for murder Twenty unarmed government soldiers, including injuries.

The BBC reported that the incident occurred in the battles of Homs, while Austrian media said that the accused refugee, who was not revealed, was boasting to other asylum seekers that he is belonging to an armed group and that he killed and injured unarmed soldiers in Syria.

After being arrest, the suspect initially admitted the killings between 2013 and 2014 in Homs (western Syria), but he retreated from his confession, saying his testimony had been misinterpreted.



However, the translator denied this and testified before the court. "The defendant told me that he opened fire against severely wounded soldiers and asked him to repeat his words and he did," the refugee's lawyer said that he will appeal.

This is the first case in Austria involving the killing of pro-Syrian regime forces.

The AGPS Monitoring and Documentation Team documented 303 Palestinian refugees who were missing since the start of the war in Syria,

including 38 women. The group reported that more than half of the missing were from the Yarmouk refugee camp south of the capital Damascus.

Activists accused pro-Syrian security groups of kidnap and arrest, either because the missing man was wanted by Syrian security, or to bargain with the kidnapped family and demand a ransom for his release.

In addition, there are a large number of missing persons in the prisons of the Syrian regime. Security is still being reticent on their fate or places of detention, as confirmed by testimonies of released prisoners that there are Palestinian refugees who are missing in the prisons of the regime.

It should be noted that the AGPS monitoring and documentation team confirmed that the number is greater because of the secrecy of Syrian security and its loyal groups about the fate of the kidnapped Palestinians, in addition to some Palestinian refugees who were kidnapped by the Nusra Front in the Yarmouk refugee camp, and by ISIS.

Palestinians of Syria; Numbers and Statistics until 11\05\2017

- The AGPS documented 3494 Palestinian victims, including 455 women.
- 1602 Palestinians are detained in the Syrian regime intelligence and security branches, including 87 women.
- The Regular Army and the PF-GC groups are besieging the Yarmouk camp for 1393 consecutive days.

- 195 male and female Palestinian refugees died due to the lack of nutrition and medical care because of the siege; most of them are from the Yarmouk Camp.
- It is now more than 1124 days without water in Deraa camp, and 975 days in the Yarmouk camp.
- Residents of Handarat camp are prevented from returning to their houses for 1468 days, while the camp is controlled by the Regular Army for more than 202 days.
- Almost 85,000 Palestinian Syrian refugees have reached Europe till the end of 2016, while the number of Palestinian refugees in Lebanon is almost 31,000, in Jordan 17,000, in Egypt 6000, in Turkey 8000, and in Gaza 1000.
