- The first anniversary of the catastrophe of a death boat sinking in front of the Italian coasts.

#### **Victims**

The young man Ahmed Mahmoud Shreih from Handarat Camp was killed during the clashes that broke out in the front of Handarat camp between the Opposition forces and the Regular Army. It is mentioned that Shreih is a member of Al Quds Palestinian brigades affiliated to the Regular Army.

#### **Recent Updates**

Bombing targeted the Yarmouk Camp for Palestinian refugees in Damascus, coincided with clashes between the Regular Army alongside with the PFGC and groups affiliated to the Syrian Opposition. News are contradicted about the one who started the crossfire, where news talks about the Regular Army and groups of PFGC was the one how started the crossfire on the residents who were waiting to get aids, what led to the suspension of distributing aids after targeting Al Righa square with a missile.

In terms of living aspect, the water is still cut from the camp for the 33 days respectively amid great difficulties of securing drinking water, where people are forced to fill and transfer the water in a primitive ways.

On the other hand, the Lebanese authorities allow the son of the dead man "Mohammed Ramadan" to enter its territories today. Mohammed Ramadan's corpse was detained in a Lebanese hospital for 13 days due to the inability of his son to return to Lebanon after heading for the performance of official exams in Syria. The Lebanese authorities permit for the son to enter came after the activating and following the case from the Palestinians of Syria Committee in Lebanon and Hamas office for the refugees affairs which helped the son to bury his father and finish all procedures.

It is referred that the Action Group for Palestinians of Syria documented a number of the Lebanese authorities' violations towards the Palestinians of Syria refugees in Lebanon in a report that was published recently. The restrictions were presented by preventing the Palestinians of Syria refugees to enter the Lebanese territory though they had the requested documents in addition to the deportation and detention of other refugees including children.

In a different context, yesterday was the first anniversary for the disaster of the boat which was carrying Palestinians of Syria and Syrians refugees and sunk in front of the Italian and Maltese coasts in 11th of October

2013. It is mentioned that hundreds of refugees drawn and lost in this accident. In the anniversary of this disaster, the Action Group for Palestinians of Syria issued a report titled as "A Homeland in the Seabed" where it shows the most important events of Palestinians drowning in the Mediterranean Sea during the period between the two summers of 2013-2014 and the two incidents of 11th of October 2013 and the 6th of September 2014. #### The Situation of the Palestinian Camps in Syria:

**The Yarmouk Camp**: - The Continuance of the siege by the Regular Army and PFGC for the 465 respectively in addition to the power cut for more than a year and a half and the water cut for 33 days respectively. **The number of the siege victims is 155 victims.** 

Al Husayneyya Camp: - The Regular Army still prevents the residents of the camp to return back to their houses for the 365 days respectively.

Al Sbeina Camp: - The Regular Army still prevents the residents of the camp to return back to their houses for the 335 days respectively.

**Handarat Camp:-**The residents left the camp since 534 days after the Syrian Opposition Groups controlled the camp.

**Jermana Camp:**-The situation is calm relatively with the continuance of the economic crises.

Al Sayeda Zainab Camp: - A state of calm was prevailed the camp with the spread of many of the Regular Army checkpoints inside the camp and its surroundings.

Khan Al Sheih Camp:-The continuance of the roads cut with the shortage of medical care and food supplies.

**Khan Danoun Camp:** - a tension state due to targeting the camp with mortar shells before days in addition to that the camp is crowded and the shortage of basic services and bothering of the Regime checkpoints.

**Dara'a Camp:** - The camp is suffering from the water cut since 180 days and the absence of basic services inside the camp in addition to the displacement of hundreds of its people due to the siege, frequent bombing, and clashes.

Al Nairab Camp: - The spread of Al Quds Brigade members which is affiliated to the Regular Army in light of the continuance of the economic crises.

Al Raml Camp: - The spread of unemployment and the residents difficult movement due to the spread of security checkpoints.

Al Aedin Camp in Hama: - A calm situation was prevailed in the camp and the suffering of high cost and the unemployment spread.

Al Aedin Camp in Homs:-the continuation of the youth displacement from the camp in light of the continuance of the living crises in the camp.
