### ***Victims***

*Ibrahim Mustafa Hussein died due to the explosive barrels that targeted the Eastern area of Khan Al Shieh camp for Palestinian refugees in Damascus suburb.*



### ***Recent Updates***

*At least two explosive barrels targeted the eastern district of Khan Al Sheikh camp in Damascus, which resulted in the death of "Ibrahim Mustafa Hassan," while at least five others were injured.*



*The shelling resulted in massive destruction of property and buildings, and also led to the cut of cable that nourishing communications network*



*in the camp as a result of damage due to the fall of barrels which led to the landline and ADSL outages.*

*It is worth mentioning that the camp had been subjected to explosive barrels days ago, while adjacent farms were exposed to daily shelling.*

*In the meantime, the regular army and some Palestinian groups continue to prevent people of Sbeina camp to return to their homes for 693 days after being forced to leave because of violent clashes that broke out between the regular army and groups of armed opposition. The clashes ended with the regular army full control on the camp, while eyewitnesses estimates that more than 80% of the camp is almost entirely destroyed, specifically the area from Maaz bin Jabal mosque till the camp's bakery known as Kurds, which constitutes the western entrance of the camp.*

*The residents have fled to neighboring towns and camps, to bring them into a new suffering not only for leaving their homes, but also it included all of their live aspects, which turned into a tragedy because of the economic conditions, the spread of unemployment, and the poor financial resources.*

*In the same context, Hundreds of residents of Hittin compound in Barza area in Damascus complain from humanitarian crises and harsh conditions due to the manifestations of the ongoing war in Syria on their living conditions.*

*The compound remained neutralizing despite it is geographically near the heart of events, while its residents were able to avoid engaging the ongoing events in Syria, despite attempts by some in order to form*



*popular committees for security, but they refused to do so strongly and denied arming anyone.*

*With the beginning of 2013 it has become more serious in the compound, where it was subjected to shelling as well as sniping that was aimed at everything moves.*



*It was mentioned that the compound was not a target but as a result of its location in a conflict area on the main road and next to the service complex (which is the driving axis of the Army regular air and security north of Damascus) and connects directly with the pro-Regime Bayader neighborhood which is full of militants from the Popular Committees.*

*The compound is surrounded from the western side by the scientific research hill which is full with guns and machine guns against the neighborhood as well as Ush Al Werwar Mountain from the north, while it connects directly from the east side with Barzah country lanes that were under the control of the Free army.*

*All these things combined made the compound a line of confrontation between the two parties.*



*In beginning of 3/2013 reside in the compound became a threat to the residents' lives as a result of the large number of shells and sniping operations as well as the siege, in addition to calls for evacuation by the two parties. Residents of Hittin compound begun to displace gradually till the compound became empty by mid-April 2013, but its residents were able to return to it later, after truce was signed between the regular army and armed groups of the Syrian opposition in Barza area.*

### **Civil Work Committees**

*Jenin Sports Club opened "Ashbal Tahreir Al Aqsa" sports session with a large presence of Yarmouk children who are displaced to the neighboring town of Yalda.*

*Hundreds of Yarmouk families were displaced to neighboring towns following the storming and controlling of ISIS into the camp since the beginning of last April.*

*The sports session includes martial art (Kick Boxing and parkour), and the program also includes sports shows, physiological support, and football Arts teaching.*





### **Malaysia**

*Palestinian activists launched an electronic campaign to demand the Palestinian Authority, the PLO, the Palestinian Embassy in Malaysia, the human rights organizations, and the UN organizations for urgent action and immediate release of the Palestinian activist "Ibrahim Abu-Kharej," who was detained about 31 days ago respectively in Kuala Lumpur, Malaysia Airport. He was detained after he left trying to resort to Europe before the Cambodian police arrest him and send him to Malaysia.*



*The activists warned at the same time, the intention of the Malaysian authorities to deport him to Syria or Lebanon, which may pose a risk to his life.*

*The activists stressed in their campaign they have made on Avaz network for society campaigns on the need for all institutions and human rights organizations to work to put pressure on the Malaysian authorities for the release of the activist Abu Kharej and facilitate traveling to the country of his choice.*



### **Statistics**

*The AGPS documentation team documented 422 Palestinian victims died due to torture in the Syrian prisons and security since the beginning of events in Syria until today.*

*Most of victims' bodies that have been documented have not been delivered to their families, but they were informed to go to the security branches that were detained in and receive their personal belongings without handed over the bodies or inform them where they were buried.*

*The AGPS documented 3044 Palestinian victims died in Syria till now, where shelling, sniping, torture, and sieges were the main reasons that led to their death.*

### **Numbers and Statistics till 11/10/2015**

- *15,500 Palestinian Syrian refugees in Jordan, 45,000 Palestinian Syrian refugees in Lebanon, and 6,000 refugees in Egypt, according to the UNRWA's statistics till July 2015.*
- *At least 36,000 Palestinian Syrian refugees have reached Europe during the last 4 years.*
- *The Yarmouk Camp: - Siege, imposed by the Regular Army and PFGC, continued for 832 days respectively. In addition, power cuts continued for more than 902 days, water was cut for 392 days respectively. The number of victims due to the siege has reached to 182 victims.*



- *Al Sbeina Camp: - Regular Army is still preventing the residents of the camp to return back to their houses for 693 days respectively.*
- *Handarat Camp: - Residents have left the camp for 894 days after the Syrian Opposition Groups controlled it.*
- *Dara'a Camp: - It is now almost 538 days without water and 70% of its buildings were demolished.*
- *Jarmana, AL Saieda Zainab, Al Raml, Al Aedein Camps in Homs and Hamma: - A relatively quiet situation in light of the economic crises.*
- *Khan Al Sheih Camp: - Roads linking the camp to the city center are still closed except for Zakia- Khan Al Shieh road.*
