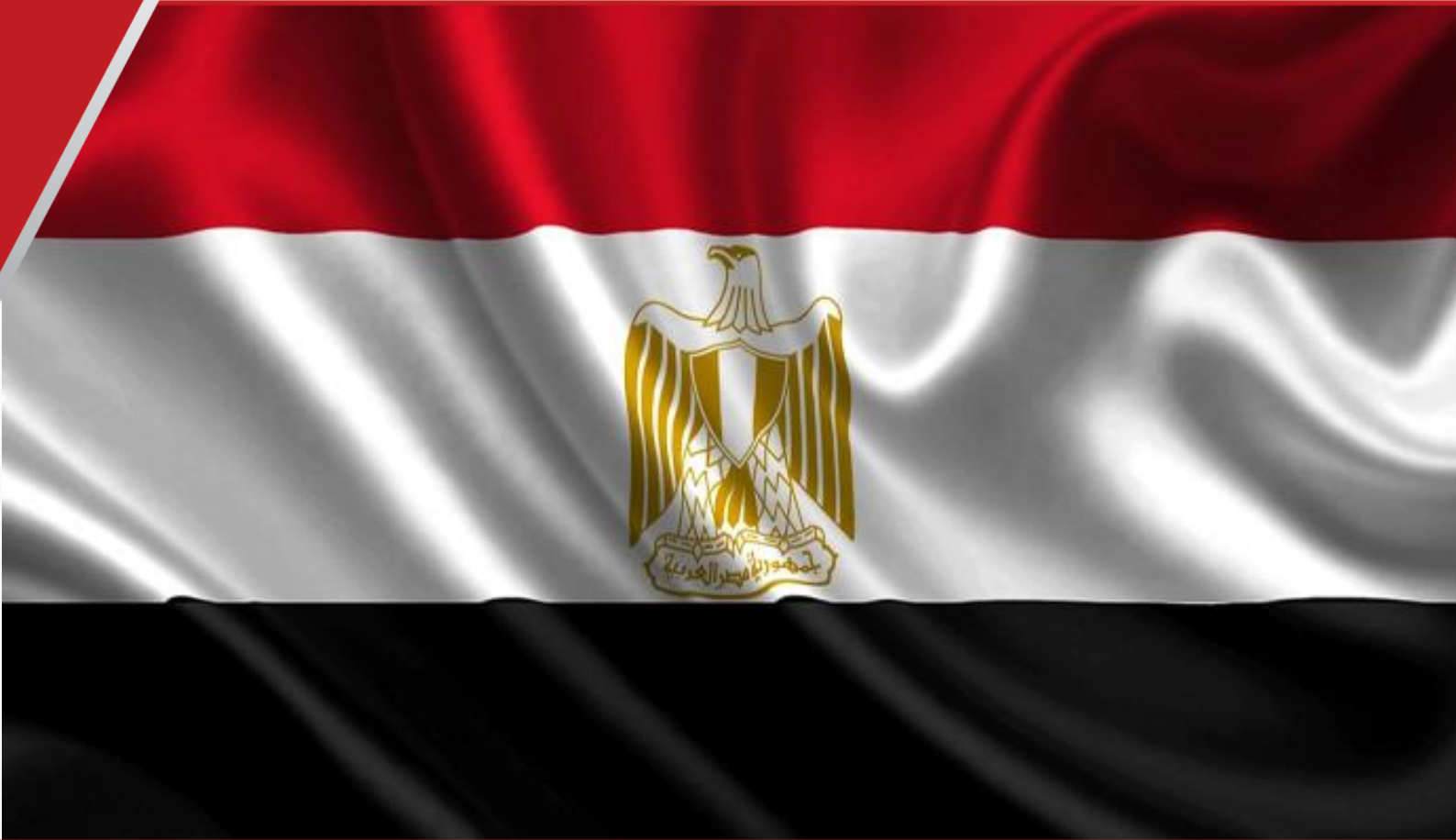

Victims

Two Palestinian refugees from Yarmouk refugee camp have died, including a child, due to the siege and lack of medical care amid the ongoing conflict in Syria.

The child, “Ghenna Amgad Nedaf” from Yarmouk camp, died on Tuesday October 10th as a result of the siege imposed by the regime forces and the Palestinian factions affiliated to it, in addition to the lack of medical care.



Palestinian refugee “Hossam El-Sayed” died on October 10th due to a sniper shot in Yarmouk camp, south of Damascus, raising the number of victims in the camp to 1328 since the outbreak of war in Syria. According to AGPS’s statistics, most of the victims died as a result of the bombardments, continuous fighting and snipers.

Latest Developments

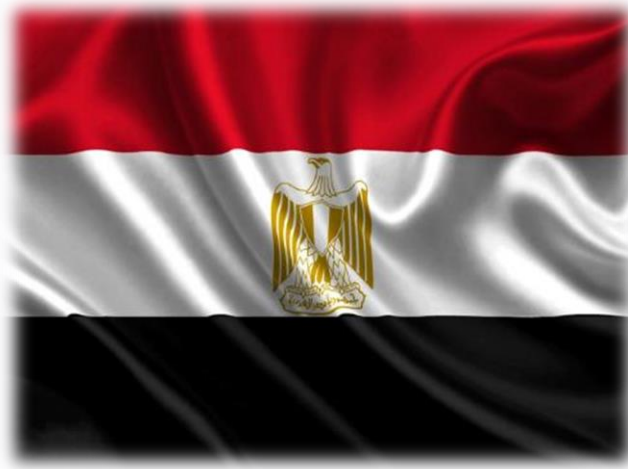
Palestinian- Syrian families in Egypt have complained that their children are denied their right to education, because of the lack of residency permits, depriving them of their right to enroll in school and to take official examinations.

According to these families, the official bodies responsible for granting residency in Egypt are procrastinating and not permitting Palestinian- Syrians any residencies under various pretexts including the lack of security clearance to allow them to obtain

residency. They added that the many problems due to the lack of access to residency in Egypt have prevailed, most importantly being subjected to legal accountability while on the move, in addition to depriving students of their right to attend school and apply for official examinations.



In south Damascus, AGPS's reporter in Yarmouk camp confirmed the outbreak of kidney diseases in the camp and its neighboring areas because of their dependence on untreated water from the wells, after the Syrian regime cut their supply of drinking water in mid-2013. According to our correspondent, the diseases vary between kidney stones, urinary tracts and sand sediments in varying proportions and quantities.

In another context, UNRWA called on parents of students enrolled in Sabinah town schools subordinated to the UN agency to review the school administrations for approval to transfer their children to the Sabinah schools, where two schools will open one for males and the other for females as a first stage. According to UNRWA, the two schools will start on the 15th of this month.

Meanwhile sources close to the regime indicated that the number of families who entered Sabinah is estimated at 1250 families, of which 450 are residents of Quneitra Governorate. Entering the city is in groups like “Al-Sharqatly,” “Al-Masaken,” and “Al-Gaathen” neighborhoods.

A Dutch woman launched a solidarity campaign in the Netherlands at the beginning of this month, to prevent the deportation of “Zein,” a 5-year-old Palestinian-Syrian child suffering from Downs’s syndrome, from the Netherlands to Iraq.

According to De Stad Amersfoort newspaper, the Dutch authorities are planning to deport “Zein” to his mother’s hometown in Iraq, which will exacerbate his illness, lead to the deterioration of his health and endanger his life due to the poor security and health conditions in Iraq.

The Dutch media confirmed that about 4,500 people joined the campaign, to pressure the Dutch Minister of Security and Justice to allow the family to stay.

Palestinians of Syria: October 11, 2017 Statistics:

- The total number of victims documented by the Action Group is 3598, including 462 women
- 1639 Palestinians are locked up behind Syrian government's bars, 105 of which are women
- Yarmouk refugee camp is under the Syrian regime army and Popular Front for the Liberation of Palestine's siege for 1,547 days in a row
- 199 refugees, mainly in Yarmouk Camp, have died due to lack of medical care and malnutrition
- Water supplies have been cut off Deraa Camp for 1284 days, and 1124 days in Yarmouk Camp
- Residents of Handarat Camp, in Aleppo have been banned from their homes for 1,620 days. Government troops have taken over the camp for more than 371 days.
- Approximately 85 thousand Palestinian-Syrian refugees fled to Europe by the end of 2016
- 31 thousand refugees are located in Lebanon
- 17 thousand refugees are sheltered in Jordan
- 6 thousand refugees are in Egypt
- 8 thousand refugees are staying in Turkey
- One thousand refugees are present in Gaza
