"Blockade Continues on Yarmouk Refugee Camp, the Regular Army Prevents People of Husseinia and Sbeina Camps to Return to Their Homes for the Ninth Month, Respectively"

Recent Updates

Strict siege, by the Regular Army and groups of the Popular Front - General Command, still imposed to Yarmouk camp in Damascus for more than ten months. Yarmouk camp suffers from a severe shortage of medical and food supplies, in addition to the stop of all bakeries and hospitals, with the exception of Palestine hospital which works in minimum energy.

In a related context, people of Yarmouk refugee camp still refuse to receive the food aid protesting at what has happened to their women in the last few days of degrading treatment, according to a statement published earlier.

For his part, Director of the Palestinian Liberation Organization (PLO) politburo in Damascus, Ambassador Anwar Abdul-Hadi accused "armed

groups" in Yarmouk refugee camp of preventing the distribution of aid, described this conduct as "inhumane". In a statement to SANA, Mr.

Abdulhadi condemned those actions and blamed those groups and their supporters responsible for increasing the suffering of the people inside and outside the camp, as he said.

On the other hand, a state of careful calm prevailed in Khan Al Sheih camp in Damascus city, coincided with the cessation of landline and ADSL internet service. Khan Al Sheih camp targeted, the day before, with explosive barrels resulting in significant damage to civilian homes and shops.

As in Aleppo, Alnairab camp was exposed yesterday dawn, with a number of shells, one hit a house, causing material damage and a number of injuries. Sporadic clashes broke out in Daraa camp south Syria coincided with explosions sounds.

Living Conditions

The suffering of the people of Husseiniya and Sbeina camps still continuous, where members of the Regular Army and groups of Palestinian factions prevent people to return to their homes, despite the

full control of the Regular Army for more than nine months, which added to the people additional financial expenses especially with the high cost of living, rising houses rents and unemployment widespread.

It is noteworthy that the Regular Army has dominated the two camps after violent clashes took place between the Regular Army and the groups of Free Army. In a related context, people of Khan Al Sheih camp in Damascus city are suffering of frequent interruptions of the roads that connect their camp to the city center because of the clashes and shelling that targeted the villages surrounding it, resulting in the loss of most of food supply. People of Dara'a camp suffers from a severe shortage of health services, due to the repeated shelling that targeted the camp, which led to massive destruction in civilian homes and infrastructure. It is worth mentioning that dozens of the camp families had been forced to flee to neighboring villages to escape from the bombing.
