### *“Sniper Shot Caused an Injury to a Palestinian Refugee and Stops the Aids Distribution in the Yarmouk Camp”*



*"Abdulnaser Mawed" was injured during the distribution of aid*

- Clashes and bombing in the Yarmouk camp.
- A boat that carries Palestinian refugees reached Italy.
- Bombing targets the vicinity of Khan Al Sheih camp in Damascus city.
- The civil organizations in the Yarmouk camp appoint a party to speak on behalf of the Yarmouk residents.
- The Syrian Security releases a Palestinian Refugee from Dara'a camp.



### **Recent Updates**

*Abdulnaser Mawed from the Yarmouk camp was injured by a sniper's shot during aids distribution to the residents of the Yarmouk camp, which is besieged since 418 days. The shooting led to stop the aids distribution by UNRWA yesterday. The Palestine Red Crescent Society in the Yarmouk camp and in the occasion of First Aid Day, performed a graduation of the course of "The Martyre Deyyab Muhanna for Nursing Procedures" that was implemented in the Palestine hospital to train the medical staff in the camp especially in light of what the camp suffers of a severe shortage of medical services after the stop of all hospitals and clinics because of the siege except Palestine hospital which works with its minimum capacity. In a related context, the organizations and commissions inside the Yarmouk camp issued two statements which decided the party that can speak on behalf of the Yarmouk residents.*



### **First aid day in Yarmouk camp**

*The organizations and commissions sent its first statement to the Civil Council inside the Yarmouk camp and the statement stressed on that the council is not responsible for managing the camp and the council is not recognized by the Yarmouk residents. The statement assured that the organizations and commissions want to cooperate with the council and the involved organizations to create one representative administration that can carry the responsibility of the camp.*



*The Second statement contains the names of the intended committee names that are authorized to speak on behalf of the Yarmouk camp. The committee names are Mustafa Al Bash, Jamal Ataba and Basel Ayyoub. It is worth to mention that the civil organizations, commissions and institution which signed the statements are The Palestine Charity Commission, Al Aqsa Charity Commission, The Charity Commission for the Relief of the Palestinian People, the United Media Office, the Civil Council, the Yarmouk Resident League, the Popular Movement, The Palestine Civil and National Commission, the Palestine Red Crescent, the Basma Social Organization, Samed Social Organization, Jafra Organization, Besan Organization, Sawaed Organization, Give Charity Organization, Al Aqsa for Arts and Education Organization, Watad Center and Thelal Center.*

*In Damascus city the bombing that targets the vicinity of Khan Al Sheih cam is still continues where heavy explosion sounds were heard, coincided with the continuation of cutting the Zakia road which is only road that connects the camp with surrounding areas. It is referred that the camp suffers of a severe shortage in medical and food materials due to the frequent cut of roads that connect the camp with the surrounding areas.*

*The Action Group received news about the boat that was carrying 550 Palestinian Syrian and Syrian refugees reached Naples Seaport, all the passengers are in good health. It is referred that the boat left Alexandria in 30th of August 2014.*

### **Civil Work Committees**

*The Hemma Volunteering Group organized a clean campaign to clean the streets of Khan Al Sheih camp in order to reduce the spread of diseases and to maintain the environment for the camp's residents. It is referred that the campaign started in 10th of September 2014 and included lifting the garbage from the streets and rinsing the streets of the camp, the residents of Khan Al Sheih camp participated in all activities and expressed their appreciation for the efforts of the Hemma Volunteering Group for what it provides of relief and service activities.*





*In the same context, the Give Charity Organization continues its Mobile Kitchen project which distributes food meals to the besieged Yarmouk residents.*

### ***Release***

*"Husine Al Nimiri" from Dara'a camp was released after being arrested for more than a year. It is mentioned that the number of the Palestinian refugees' detainees in the Syrian Regime Prisons is 730 refugees since the beginning of the Syrian conflict till the end of August 2014, according to the Action Group for Palestinians of Syria documented statistics.*
