
"140 PLA Victims Died since the Beginning of War in Syria, and News about Al Qadeseia Brigades' Arrival to Al Thaala Military Airport in Swaidaa Suburb"

Palestinian Liberation Army

The AGPS documentation and monitoring team documented the names of 140 PLA victims who died since the beginning of the ongoing war in Syria; most of them died during the military operations in Damascus suburb.

The group revealed that 42 PLA victims died since the beginning of 2015, including four members died in January 2015, 18 in February, 19in the beginning of April 2015, including 13 died during fighting between the regular army and ISIS in Swaidaa province suburb \$ southern Syria.

In the same context, social networking and websites shared news about the arrival of nearly 250member of the "Qadeseia Brigade" affiliated to the PLA on the evening of Friday, 12 / June - into Al Thaala military airport in western suburb of Swaidaa.

The 250 members arrived in order to support the Syrian regime forces, where sources confirmed that those troops entered by civilian cars with light and heavy weapons to, across the agricultural roads connecting western suburb of Swaidaa with the airport, while the AGPS could not assure the news from other sources.

Meanwhile, the AGPS received messages and calls from a number of activists and families of victims and recruits who are required to perform the military service appealing the PLA General Staff, the PLO, and the stakeholders not pushing their children in the conflict in Syria, not sending them to areas of tension, and to stop bloodshed of Palestinian youth in a battle which is not theirs.

It should be noted that Palestinian refugees in Syria are obliged to perform the PLA military service, and anyone who refuse would be exposed to prosecution and imprisonment, forcing many young people, who refuse to perform military service during the war in Syria, to leave and travel to neighboring countries.

Victims

The relief activist "Mohammed Khaled Nofal" died due to shelling that targeted Khan AL Shieh Camp in Damascus suburb with explosive barrels. Nofal is a volunteer for Jafra institution in Khan Al Shieh camp, and he is a father of two children.

Recent Updates

A state of fear and tension prevailed among residents of Khan Dannon Camp in Damascus suburb, following the outbreak of violent clashes in the vicinity of the camp between the regular army and the Syrian armed opposition groups.

Moreover, residents of the camp live in a state of instability and uncertainty of their unknown fate because of the rising hostilities' pace in the adjacent regions and towns between the Syrian opposition forces and the regular army, and the participation of some residents belonging to the PFGC and Fatah al-Intifada in the fighting alongside the regulars army, making the camp vulnerable to shelling and fall of a number of shells on different parts of it causing many victims and wounded.

On the other hand, and because of the geographical position enjoyed by khan Dannon camp, the regular army has tightened its security siege on entrances and exits, as it put a checkpoint on the main gate, and toke the streets and as a way for its mechanisms to the battlefront with opposition forces in the neighboring villages.

In terms of living aspect, residents are complaining of severe living crises manifested in food shortages, unemployment widespread, poverty, and the continuation of electricity, water, and communications cut for long periods.

In the north of Syria, Al Qatifa checkpoint members arrested the Palestinian woman, Laila Abu Amr, known as Um Mahmoud from Al Raml Camp in Latakia. She was arrested while traveling to Damascus to visit her detained son in Sednaya prison.

Meanwhile, the detained refugee, "Walid Assaf," was released after being detained for more than three weeks.

It is worth mentioning that the AGPS has documented nearly 70 detainees from Al Raml camp in Latakia, who were detained the Syrian regime's prisons.

In turn, residents of Al Raml camp complain of continued raids and arrests campaigns carried out by the Syrian security services between now and then to the homes of the camp and increase the suffering of its population, where the pro-Syrian Palestinian groups raided their homes and controlled some of them to be their headquarters.

Youth of the camp also suffers from the prosecution of the Syrian security services in order to perform the PLA military service, forcing many of them to escape out of the country.

Residents of AL Raml camp live in a state of calm amid the continuing economic suffering, where they are complaining of rising prices of foodstuffs, as well as the high cost of rent homes

In the meantime, a checkpoint of the air security, which is located after the city of Hama from the north and before "Mork" area, arrested the Palestinian refugee woman "Mania Ahmed Salayma," from Al Aedein Camp in Homs yesterday. It is referred that she is at the beginning of her thirties, originally from Al Shajara Village in Palestine.

Lebanon

Under the slogan of "UNRWA was founded for the Palestinians not to starve and displace them," dozens of displaced Palestinian Syrian families in Lebanon organized a sit-in in front of "UNRWA" office in Wadi Al Zain area at the city of Sidon southern Lebanon.

The sit-in came as a rejection of the resolutions issued by the UNRWA recently, which stated to reduce its services for the Palestinian refugees

in general, and the Palestinians of Syria in particular, where it cut shelter allowance, reduced the amount of food aid, as well as it cut financial assistance to about 1200 Palestinian Syrian families.

The protestors called on the Palestinian factions, the PLO, and the human rights organizations to urge UNRWA in order to back down its decisions, and to put pressure on donor countries to pay their financial obligations to UNRWA.

At the end of the sit-in, protesters handed a protest note to the Director of the UNRWA office in the territory of Sidon and Al Kharoub area, Dr. Ibrahim al-Khatib, in which they demanded to reconsider its decision, which will have negative repercussions on the living and humanitarian conditions.

UNRWA announced on its website that the State of Kuwait made a donation of 15 million\$ to the UNRWA for the work provided for Palestine refugees in the Middle East.

The announcement of this new donation was made during a ceremony held in Geneva on June 11, at New York City.

For his part, Commissioner-General of UNRWA, Mr. Pierre Krenpol said that "this welcomed donation comes at a critical time for UNRWA, at a time when developments taking place in the region lead to a significant increase in the needs of refugees who we serve, and most of them found themselves trapped in the midst of civil war in Syria, and who are living under siege and occupation in Gaza and the West Bank."

Numbers and Statistics till 14/6/2015

- 80,000 Palestinian refugees escaped from Syria, including 10,687 refugees in Jordan, 51300 refugees in Lebanon, and 6,000 refugees in Egypt, according to the UNRWA's statistics till February 2015.
- At least 35,000 Palestinian Syrian refugees have reached Europe during the last 4 years.
- The number of Palestinian detainees who were documented by the AGPS has reached 888 detainees, and 398 victims were killed due to torture in the Syrian prisons.
- The Yarmouk Camp: Siege, imposed by the Regular Army and PFGC, continued for 717 days respectively. In addition, power cuts continued for more than 787 days, water was cut for 277 days respectively. The number of victims due to the siege has reached to 176 victims.
- Al Husayneyya Camp: Regular Army is still preventing the residents of the camp to return back to their houses for 598 days respectively.

- Al Sheina Camp: Regular Army is still preventing the residents of the camp to return back to their houses for 579 days respectively.
- Handarat Camp: Residents have left the camp for 781 days after the Syrian Opposition Groups controlled it.
- Dara'a Camp: It is now almost 424 days without water and 70% of its buildings were demolished.
- Jermana, AL SaiedaZAinab, Al Raml, Al Aedein Camps in Homs and Hamma: A relatively quiet situation in light of the economic crises.
- Khan Al Sheih Camp: Roads linking the camp to the city center are still closed except for Zakia- Khan Al Sheih road.
