"Assassination of Relief Activist in Yarmouk Camp, and Bombing on Zamalka, kills four Palestinian Refugees, Including three people of one family"

Victims

Alias Abu Abed Shamdien" Abu Al Abed Khalil" was killed yesterday morning in Yarmouk camp, after he was assassinated by an armed groupin three bullets from a pistol silencer in the street of Safad. Mr. Khalil was a member of Yarmouk Sons' Gathering and Civic Council of Yarmouk refugee camp.

Ahmed Ali Qassem and his two sons Mohammed Ahmed Qasim and Moa'weya Ahmed Kassem and Abu Waheid Ghazi were killed due to the bombing of Zamalka area in Damascus city.

Mohammed Jamil Suleiman 58 years from Al Hajar Al Aswad neighborhood in Damascus city was killed under torture in the prisons of the Syrian Regime.

Alaa Omar Abu Nasser, member of PFLP (General Command) was killed in the clashes in the Yarmouk refugee camp.

Recent Updates

Bombing targeted Alnairab camp in Aleppo northern Syria with two missiles, one targeted Ziad Abu Hassan house without causing any casualties, while the second rocket landed on agricultural land in front of the house.

Assassination Abu Al Abid Khalil, relief activist and member of Yarmouk Sons Gathering and Yarmouk Civic Council, by an armed group inside the camp, yesterday.

A number of mortar shells targeted Yarmouk camp, yesterday evening; fell at different places, Alrija yard, Loubieh Street and the vicinity of Al Waseim mosque, causing limited material damages.

Snipers were shooting towards Yarmouk Main Street, and clashes between groups of the Popular Front - General Command supported by Regular Army on one hand and groups of Free Army on the other.

In terms of the political movement to resolve Yarmouk camp crisis, State Minister for National Reconciliation "Ali Haider" confirmed, yesterday, following a meeting with the Director of the Political Department of the PLO in Syria "Anwar Abdul-Hadi," the Syrian State's intensity to end the crisis of Yarmouk camp and end the Palestinians and Syrians suffering.

For his part, Mr. Abdul Hadi said:" during the meeting we agree to start a new and clear move to resolve the crisis in Palestinian refugee camps, particularly Yarmouk camp, through giving a final opportunity for armed groups to reach a peaceful political settlement with them, and most importantly to evacuate the camp of weapons and armed groups".

Abdul Hadi added that "What is required from the stranger armed is to get out of the camp and the armed from camp, who involved, to settle his situation and get back to his normal life and to take advantage of the amnesty issued by the Syrian leadership".

On the other hand, Yarmouk camp residents still refuse receiving humanitarian aid for the ninth day respectively, in a protest against the continuation of the blockade imposed on the camp and the mistreatment they receive during their receipt of food parcels.

Also, Regular Army widespread in Khan Danon camp yesterday, and a military vehicles fired heavy fire at the center of the camp, causing panic among people, it soon became apparent that the goal was to open the way for a mechanism that carry a number of Regular Army injured, While in the sides of the camp, clashes broke out between groups of the FSA and the Regular Army towards Taiba town.

In Damascus city, remaining people in Al Sayeda Zainab camp suffer of stifling humanitarian crisis touched their livelihood as a result of the acute shortage of food supplies and bread, also complain of the continued power outages and telecommunications network for long periods.

Lebanon

Action Group received information about allowing the Lebanese authorities to enter the three Palestinian Syrian refugees (Hossam Al Mawe'd, Mustafa and Hossam Al Yateim) stranded on the Lebanese-Syrian border into Lebanon after regularizing their status.

It is noteworthy that the three young men were among a group of nearly 49 Palestinian and Syrian refugees, were deported from Lebanon to Syria after being detained by the Lebanese Authorities on charges of having fake passports, while trying to travel from Rafik Al Hariri airport in Beirut to Libya, but the three young men refused to return back to Syria, fearing for their lives and remained stuck since 3rd of May in the neutral zone at the Lebanese-Syrian borders.

Hungary

In the Action Group's follow-up to the issue of Palestinian Syrian refugee "Rakan Hussein," who declared a hunger strike for five days in Hungary, protest against the obstruction of the Hungarian authorities to reunite with his children on the pretext of not recognizing their Syrian passports, Action Group confirmed that Rakan Hussein moved his sit-in from his residence to the headquarter of the International Red Cross in Budapest.

The correspondent added that the International Red Cross official met "Hussein" and told him that the Red Cross would not be able to provide any help to him.

The correspondent reported that the lawyer, in charge of addressing the issue, came to the place of the protest and asked him to leave the place immediately, because he would be subjected to arrest and Contingency imprisonment for three days, in case he decided to sleep in the street, therefore "Rakan Hussein" renew his appeal to human rights organizations, United Nation bodies and human rights organizations to intervene to reunite his family.




Rakan Hussein Strike in front of the headquarters of the International Red Cross
