### ***“Palestinian Victims Due to Homs Explosions and Explosive Barrels in Khan AL Sheih Camp”***



**The Explosive Barrels in Khan AL Sheih Camp**

- Explosive barrels on Khan AL Sheih Camp.
- Two rockets were dropped in Al Nairab camp.
- Resumption of food aid distribution to the residents of the Yarmouk Camp.
- The establishment of sand mounds in Daraa camp for protection from sniper bullets.
- General Authority for Palestinian refugees of the temporary Syrian government object to the news of a refugee in Kilis center on hunger strike and demanding to delete it.

### ***Victims***

*Four Palestinian victims because of the continuing of the ongoing conflict in Syria, including three children were killed due to an explosion of two bombed cars in Ekrima neighborhood in Homs, and the fourth victims is a woman who was killed due to the bombing of Khan AL Sheih Camp with explosive barrels. The victims are:*

*the children, Reem and Raghad Baker, and Lana Aliwa, they were killed due to wounds they attained because of two explosive cars near Ekrima AL Makhzoumi elementary school.*

*The teacher "Souria Al Abbas" from Khan AL Sheih Camp in Damascus city was killed due to injuries with explosive barrels shrapnel that were dropped by the helicopters on AL Iskan Street and the vicinity of AL Rida Street.*

### **Recent Updates**

*The two sisters "Reem and Raghad Bashar al-Bakr," and the female child, "Lana Elewa" were killed and dozens of civilians were injured following the explosion of two bomb cars near the elementary school Ekrima AL Makhzoumi, Ekrima neighborhood, which is inhabited by Syrian and Palestinian citizens.*

*The Eyewitnesses reported that a car bomb exploded near Almkhзумي school in Ekrima neighborhood pro-Syrian regime, minutes later followed by a second bombing at the southern section of the school and near AL Zaeim hospital in Ekirma neighborhood with the influx of people to check on their children and the moment of children exit from their schools.*

*Meanwhile, heavy bombing with explosive barrels targeted Khan AL Sheih Camp in Damascus city, where helicopter dropped four barrels simultaneously and affected the vicinity of AL Rida and AL Iskan Military Street. The bombing resulted in the death of the victim, "Soureia AL Abbas" and a number of wounded in addition to the large destruction in the homes and property of the people.*

*This bombardment comes under the conditions of the continued deterioration of security in the areas surrounding the camp which led to the closure of Zakia -Khan Al Sheih road which is the only road linking the camp and the city center of Damascus. The closure resulted in a stifling living crises and scarcity in food and bread, in addition to the suffering of the continuing power, communications and Internet network cut for long periods.*

*On the other hand, two rockets were dropped in AL Nairab Camp; one of them was dropped in an agriculture land and the second in an empty house, and resulted in only material damages.*

*Meanwhile, the barriers of the Regular Army and groups of the PF-GC, who besieged the Yarmouk camp for more than 438 days respectively, allowed the entry of limited quantities of food aids to be distributed to the residents. The besieged people of the Yarmouk Camp gathered since early morning at AL Righa square in the middle of the Yarmouk main Street hoping to get a food ration to alleviate the effect of the ongoing siege.*





*For its part, the forces of the Syrian opposition, which controls Daraa Camp southern Syria in cooperation with the General Authority for Palestinian refugees in Syria to lift sand barriers in all areas of contact with the barriers of the regular army, in order to protect the people of the camp from the heavy spreading of snipers in the streets, which led to the siege of the camp and the inability of people there to move freely for fear of being targeted by snipers who shoot at anything moving in the streets.*

*In a related context, the rest of the residents are still complaining of a lack of fuel, bread and rising raw material prices dramatically, and what makes it more difficult is the high rate of unemployment and most of the population stopped working due to the deterioration in the security situation in Daraa Camp.*

### **Civil Work Committees**

*The relief office in Palestine Charity committee continues to work on the distribution of monthly guarantees and Eid gifts to needy families in the Yarmouk refugee camp for the third day respectively. The distribution included (the families of orphans, wounded and missing). As in Lebanon, the Committee of Palestinians of Syria in Lebanon has participated yesterday with Al Islah Association and AL Raafa endowment to distribute food rations to displaced Palestinian families from Syria in the city of Sidon in southern Lebanon.*



### **Kilis- Turkey**

*The Action Group for Palestinians of Syria received a letter from the General Authority for Palestinian refugees in Syria - Syrian temporary government to object on the news that was published by the Group about the hunger strike of the refugee "Yusuf Ahmed Abu Khadra" (24 years) from Daraa camp to protest the deplorable living conditions suffered in Kilis shelter on the Syrian-Turkish border.*

*The General Authority for Palestinian refugees in Syria also demanded the group to delete the news for being "not investigating the truth," as described by the letter, and without returning to the media office to hear the position of the General Authority from the action of refugee "Yousef Abu Khadra."*



*The Group quoted yesterday the news of the Palestinian refugee Abu Khadra strike protest against poor living conditions inside the center, and the commitment of the Group in the transfer of all points of view, we publish the letter arrived from the body as it is to represent a formal response from the Commission on the mentioned news.*

*The Action Group stressed that they are not obliged to delete any news as long as it reflects the viewpoint of an interview. As the text of the message as it received from the General Authority for Palestinian refugees in Syria - Syrian temporary government:*

*Dear Action Group for Palestinians of Syria,*



Greetings,

*We would like to express our protest on the news related to the refugee Yousif Abu khadra who is on hunger strike in Kilis shelter of the General Authority, and the reason for our protest is that you take the news without truth and without returning to the media office to hear the position of the General Authority from the action of the refugee Yousef Abu Khadra.*

*We wish you the accuracy and objectivity in the transfer of this news, which it was based on your correspondent from inside the center, and we would like to make it clear to you that what was happened is not a refugee strike protest against the living conditions, but the process of blackmail from this person who goes in a hunger strike in order to compel the Commission to pay \$ 1500 TL to him .*

*This led to the intervention of the Turkish security that considered the refugee Yousif Abu khaddar as he violated the Turkish laws and prosecution and he is considered as wanted to the security after he escaped from the center because of this shameful act. We inform you that your correspondent from inside the center did not take the opinion of the General Authority or asked for the position, which in turn acted unprofessionally and he will take it as personal responsibility.*

*And because we respect the role of your group in the transfer of the true of the suffering of our people, we ask you to delete this news otherwise we will be forced to protest publicly about what was published on your page as considered including a distortion of the Commission's work and its role in the time that we bear the large burden with the help of our people and to stand by them.*
