"Airstrikes against Khan Al Shieh Camp in Damascus Suburb Result in the Death of a Child and a Number of Injuries"



- A Palestinian Refugee Died Due to Shelling at the Outskirts of Khan Al Shieh Camp

Victims

The-2 and a half-year- child, Israa, died due to wounds she attained during the shelling that targeted Khan Al Shieh camp in Damascus suburb. An airstrike targeted the eastern lane of the camp and resulted in one victim and a number of injuries, in addition to the mass destruction of civilians' houses. Activists confirmed to the AGPS that warplanes



which targeted the camp were Russian and Syrian.

Meanwhile, the-17-year- Palestinian refugee, Mohammed Bashnaq (Abu Mosaab,) from Sbeina camp, died due to a previous shelling that targeted the outskirts of Khan Al Shieh camp two days ago.



Recent Updates

Residents of Yarmouk Camp Movement "Al-Buraq Brigades" announced the abandon of Nusra Front and the withdrawal of its members from Rija Square to the areas controlled by ISIS within the Yarmouk camp. Nusra



Front was also accused of mismanagement and misdealing with civilians and the assassination of the relief activist "Bahaa Alameen.

In a statement that was posted on Facebook, Esam Albitar "Abu Alabed," leader of Residents of Yarmouk Movement " Al-Buraq Brigades," confirmed that this abandon came against the backdrop of our opposition to the agreement with the regular army which stated the withdrawal of its members towards the city of Idlib and emptying the region of fighters and weapons, and leave the area to an unknown fate. The second reason is because of the refusal of Nusra to hand over Rabat points in Rija and support us with arms either a trust or for money.

Albitar pointed out that they willing to stay inside the Yarmouk camp and to defend it forced them to coordinate with ISIS and to withdraw towards their controlled areas inside Yarmouk.



The statement accused Nusra of assassinating the relief activist, Bahaa Alameen, in addition to the mismanagement and misdealing with civilians, as well as they force civilians to hold weapons. Any civilian who refuse to hold a weapon will be left in the camp to die.

Alwatan newspaper reported that negotiations between Nusra and the regular army are still ongoing, however it needs two or three days to be done, noting that there are obstacles that hinder the completion of the agreement.

On a different context, Handarat Camp for Palestinian refugees and its vicinity were exposed to violent bombing with explosive barrels and rockets, coincided with violent clashes between the Syrian Army alongside Al Quds Brigade with the Opposition armed groups using all kinds of weapons heavy and light.

It is mentioned that the camp is empty of its residents because they were forced to leave their camps due to violent clashes between the Regime and the Opposition since about 1173 days and ended with the control of the Opposition over the camp. However, the Opposition forces prevented the residents to return back to the camp since then, where the camp was exposed to frequent bombing with explosive barrels all this period which led to the destruction of about 80% of the camp's houses.

Turning to Greece, where the suffering of the child Jawad Alabwini continues inside the refugee camps in Greece. The child and his mother reached Greece after they were exposed to huge risks and health suffering launching from Syria to Lebanon to Turkey and at last Greece, where the child was exposed to brain hurt due to Gas bombs that targeted Yarmouk camp. The child suffers from strange cruel pain which let him leave the camp due to the interference of UNRWA. His mother went to Lebanon to get treatment for her child but after a year of waiting and transferring among hospitals and economic crises, the mother lost hope to give treatment for her child which prompted her to return to Syria then

to Turkey in a dangerous trip especially for the injured child. The mother left Turkey through death boats hoping to reach Germany then she was stuck in Greece with her injured child for several months in addition to the instability of the child's health situation.



AGPS published appeal calls from the family of the child Jawad Aboni for all the Palestinian and European civil and official organizations to interfere to put an end to the suffering of the patient child who is stuck now in the refugees camps in Greece, none of the organizations responded to the appeals till now, according to the child's family.

In Lebanon, UNRWA filled the ATM cards of the Palestinian Syrian refugees displaced to Lebanon as \$100 rent allowance for each Palestinian Syrian family in Lebanon and 40 LL which is about \$27 for each person.

UNRWA declared that it was able, through the UNRWA's appeal for the Syrians for 2016, to continue providing financial aid to the Palestinian Syrian refugees in Lebanon and qualified to get the financial aid as follows: 40 L.L food allowance for each person, UNRWA noted that this allowance will continue till the end of 2016, \$100 shelter monthly allowance, where this allowance will be provided on monthly basis beginning from March till October 2016.

Palestinians of Syria; Numbers and Statistics till 19\07\2016:

- 15500 Palestinian Syrian refugees are in Jordan
- 42.500 Palestinian Syrian refugees are in Lebanon
- 6000 Palestinian Syrian refugees are in Egypt, according to the UNRWA statistics till July 2015
- 8000 Palestinian Syrian refugees are in Turkey
- 1000 Palestinian Syrian refugees are in Gaza
- More than 71.2 thousand Palestinian Syrian refugees have reached Europe till the End of December 2015
- The Yarmouk Camp: siege, imposed by the Regular Army and PFGC groups, continued for 1127 consecutive days. Power cut continued for more than 1189 days, water was cut for 678 days respectively. The number of siege victims is 187.
- Al Sbeina Camp: Regular Army is still preventing the residents of the camp to return back to their houses for 981 days respectively.
- Handarat Camp: All Residents have left the camp for about 1 173
 days after the Syrian Opposition Groups controlled it.
- Dara'a Camp: It is now almost 834 days without water and almost 70% of its buildings were demolished.
- Jermana, AL Saieda ZAinab, Al Raml, Al Aedein Camps in Homs and Hamma: A relatively quiet situation in light of the economic crises.
- Khan Al Sheih Camp: Roads linking the camp to the city center are still closed except for Zakia- Khan Al Sheih road.
