"Palestinians of Syria Protest in front of the Greek Parliament demanding to solve their Case....Promising steps towards solving the Detained Palestinian Syrian Refugees in Karmouz prison in Alexandria, Egypt"

Statistics

The Action Group for Palestinians of Syria insured that the number of victims from the residents of Jermana camp in Damascus suburb, who died since the beginning of the events in Syria, is 23 victims, including 12 victims due to boming,5 shots, 5 were killed after being kidnapped, and a refugee due to a car bomb.

Greece

A number of Palestinian Syrian and Syrian refugees, who were rescued by the Cypriote Greece coast guards on 26/9/2014, in charge of illegal immigration, as they were placed in one of the refugee camps, performed a protest in front of the Greece Parliament in Syntagma square in Athens protesting on their humanitarian bad situations demanding to solve their case and allow them to immigrate to the European countries.

It worth mentioning that the Greek authorities become treating with the refugees, who came to their lands to immigrate to the European countries, in an inhumane ways, as On 11/12/2013 the Greek coast guards caused death of the child Abdelrahman Al Sadi and his Mother Maha Al Sadi due to the drowning of their boat.

According to one of the survivors' testimony, members of the Greek coast guards pulled them back to the Turkish water which led to the sinking of the child and his mother.

The Authorities arrested 108 Palestinian refugees including 25 children and 36 women and a number of wounded on 20/8/2014 during their trial to travel to one of the European countries through its airport in charge of illegal immigration and detained them in the Greek Symi Island, then they were released after the interference of a number of Human rights organizations and International organizations. Similar incidents were recorded few weeks ago, where one of the migrants said that the Greek Authorities pulled their boat in the sea and left them in the Turkish Regional Water and they were rescued by the Turkish coast guards.

Recent Updates

Al Reda Street in Khan Al Sheih camp for Palestinian refugees was targeted with a mortar shell which led to material damages coincided with explosion sounds from the surrounding areas where all roads that connect between the camp and the city center are still closed except for the Zakia road in Khan Al Sheih.

The Yarmouk camp witnessed heavy clashes between the military groups of the Syrian Opposition from one side and the Regular army and the PFGC from the other side; they used the middle and heavy weapons. The residents of the Yarmouk camp are still suffering of the water cut for 72 days respectively where they are obliged to go to the far areas in order to bring drinking water which exposes their lives to danger. All this suffering comes in light of the continuation of the strict siege that is imposed on the Yarmouk camp for more than a year and a half by the Regular Army and the PFGC.

Khan Danoun residents in Damascus suburb are suffering of the severe drinking water shortage which increases the bad living situation inside the camp specially the shelter centers which receive hundreds of displaced families from the surrounding areas because of the bombing and siege. In addition to that Al Taiba town which surrounds the camp witnesses frequents bombings and clashes.

In Jermana camp, the resedents demanded the Public Commission for the Palestinian refugees not to flee out of their responsibilities towards the Palestinian refugees specially the residents of the camp who are suffering of the unavailability of basic services in addition to the problems of the infrastructure such as sewage, power and telecommunications where the residents demanded frequently from the members of the Public Commission for the Palestinian refugees in the camp to raise their complains to the Director General Main Office but without any advantages.

Egypt

The Action Group for Palestinians of Syria received news about that there are promising steps in the situation of the detained Palestinian


Syrian refugees in Karmouz prison in Alexandria who are detained under the charge of illegal immigration. The information emphasized that the lawyer of the Syrian Palestinian refugees was able to change their case from illegal immigration to escaping of the military conflicts in Syria. In a related context, a number of detained refugees expressed their worry to be deported to Syria after the one of the Palestinian Embassy representatives in Cairo told them that they have no choice but to be deported or detained. According to one of the refugees, their deportation to Syria is so dangerous on their lives because most of them are wanted to the compulsory military services.

On 8th of November 2014, a number of human rights activists and activists launched a campaign under the titled as "Well Treatment to the Palestinian and Syrian Refugees" on AVAAZ organization's website where the activists appealed the Egyptian Authorities not to deport the detained Palestinian and Syrian refugees because it is so dangerous on their lives. It is worth mentioning that more than 100 Palestinian and Syrian refugees are detained by the Egyptian Authorities in Karmouz prison after they were victims of cheat by one of the smugglers in Turkey.

The Palestinian Camps in Syria, Numbers and Statistics

- The Yarmouk Camp: Siege, imposed by the Regular Army and PFGC, continued for 502 days respectively. In addition, power cuts continued for more than 585 days, water was cut for 72 days respectively. The number of victims due to the siege has reached 157 victims.
- 41 Palestinian refugees were killed outside of Syria.
- 95 PLA members were killed due to Clashes in Syria.
- Al Husayneyya Camp: Regular Army is still preventing the residents of the camp to return back to their houses for 404days respectively.
- Al Sbeina Camp: Regular Army is still preventing the residents of the camp to return back to their houses for 373 days respectively.
- Handarat Camp: Residents have left the camp for 573 days after the Syrian Opposition Groups controlled it.
- Dara'a Camp: It is now almost 219 days without water and a complete absence of basic services.
- Khan Al Sheih Camp: Roads linking the camp to the city center are still closed except for Zakia road.
