#### **RECENT UPDATES**

AGPS has documented only 14 bodies had been handed by Syrian regime to their families. The number of Palestinians who tortured to death is 431, which most of them have not been handed. Activists indicated that information leaked from Al-Mazzeh military hospital about the fate of victims, the source assured that mass graves had been dug in the hospital to bury the bodies. AGPS could not validate the information from independent sources.

AGPS had demanded the Syrian regime to reveal the fate of detainees and release them, considering what is happening inside the Syrian prisons as a crime by all standards.



In a different context, the plight of displaced Palestinians of Handarat camp in Aleppo lasts for 998 day. The inhabitants of the camp had fled in a wake of dominating the camp by Syrian opposition in 2013. The families, which lived in the ninth unite in Aleppo University housing compound, were asked later to leave the unite to nowhere.

In terms of the situation of the camp, the shelling is still continuing daily. In addition, the clashes between the conflict parties converted the camp

into a war field. Houses and schools in the camp had been hugely affected over the past two years. The location of the camp represents one of the most strategic spots in north Aleppo as Al-Kendi hospital located right south of the camp, and few hundred meters from the main road to the central prison of Aleppo. It is noteworthy that AGPS documented 43 victims and 32 detainees from Handarat Camp.

In Khan-Esheih camp, the Palestine association charity organised sport activities for children. The marathon took place in the camp, involving 72 participants, concluded by honouring the winners and the supervisors of the competition. The activity comes under severe conditions in the camp, which is blocked and semi-besieged. The 15000-inhabited camp is subjected to heavy shelling every now and then, and hundreds of families left their homes to safer areas inside and outside Syria.



Moving to Lebanon, a humanitarian appeal has been launched to help a Palestinian child patient suffering from a serious illness. The 7-year-old, "Jawad Ebwini", needs a special healthcare and his life is at high risk, the medical source said. The child's mother, "Kinaz Alnabulsy", appealed to charities and relief organisations to help her family, lives in Ein-

Elhelweh camp in Lebanon. She continued, "Jawad had been subjected to tear gas in Alhajr-Alaswad 3 years ago.



He was affected by inhaling the tear gas, and his situation dramatically deteriorated due to the starvation and shortage of medicine as we were besieged in Yarmook camp with no healthcare". Alnabulsy bitterly revealed that Jawad's situation has been diagnosed later with Cerebral Palsy. Jawad's suffering has not stopped at this point; he and his family were expelled from their rented house because of the delay in payment. Despite of the TV report on Aljadeed channel, in order to call for assistance for Jawad and his family, there was no response so far.

On the other hand, AGPS has revealed new figures of Palestinian victims in 2016. The Documentation and Monitoring team has listed 14 Palestinian who were killed in different areas inside and outside Syria since the beginning of 2016. The list included 6 victims killed due to the hostilities in the country, and 4 victims tortured to death, whereas 4 have drowned in the Aegean Sea. The total number of Palestinian victims over the last 5 years is 3110, AGPS said.

#### Palestinians of Syria in numbers and statistics until 20 January 2016

- 15,500 Palestinian Syrian refugees in Jordan, 42,500 Palestinian Syrian refugees in Lebanon, and 6,000 refugees in Egypt, according to the UNRWA's statistics till July 2015.
- More than 71,200 Palestinian Syrian refugees have arrived Europe until the end of December 2015.
- The Yarmouk Camp: still under siege imposed by the Syrian Regime's Army and PFLP-GC (Popular Front for the Liberation of Palestine General Command), continued for 921 days respectively. In addition, power cuts continued for more than 1009 days, water cut for 499 days. The number of victims due to the siege has reached to 187 victims.
- Al Sbeina Camp: Syrian Regime's Army still preventing the residents from returning back to their houses for 805 days respectively.
- Handarat Camp: All of its residents have left the camp for 998 days after the Syrian Opposition Groups controlled it.
- Dara'a Camp: Running water cut continues for 658 days, and 70% of its buildings were distroyed.
- Jarmana, AL-SaiedaZainab, Al-Raml, Al-Aedein Homs and AedeinHama: A relatively quiet situations in light of the economic crises.
- Khan Al Sheih Camp: Roads linking the camp to the city center are still closed except for Zakia-Khan EShieh road.
