"3,894 Palestinian Refugees Pronounced Dead since Outburst of Syria Warfare"

- UNRWA Delegation Inspects Schools, Facilities in Yarmouk Camp
- Daraa Residents Appeal for Urgent Action over Water Crisis
- Palestinian Refugee Mohamed Bobali Secretly Held in Syrian Jail for 7th Year



Latest Developments

AGPS has documented the death of 3,894 Palestinian refugees from Syria, including 478 women and girls, since 2011, as a result of war related incidents.

Yarmouk Camp topped the list of victims with 1,408 casualties, followed by 263 in Daraa Camp, 202 in Khan Eshieh Camp, in Rif Dimashq, 167 in Aleppo's AlNeirab Camp, and 123 in AlHusainiya Camp.



188 Palestinians also died in unknown locations while 1,543 others were pronounced dead in refugee camps and communities across war-torn Syria.

AGPS found out that 1,198 refugees were killed under shelling; 1,063 were fatally gunned down, while 558 others were tortured to death in Syrian dungeons.

Scores of Palestinian refugees have also been left wounded, including dozens who have undergone limp amputation or eye loss.

Over 1,700 Palestinians have been enduring mysterious fates in Syrian dungeons, according to AGPS data.



Meanwhile, a senior UNRWA delegation showed up in Yarmouk to inspect schools and facilities destroyed in onslaughts launched by the Syrian government forces and their war abettors.

The delegation comprised the director of UNRWA operations in Syria Mohamed Abdi Adar and directors of UNRWA programs, along with the General-Director of the General Authority for Palestinian Refugees in Syria, Ali Mustafa.



The delegation toured Yarmouk streets and neighborhoods and took note of the residents' demands.

The residents called for activating the role of UNRWA, the municipality, and local institutions and for rehabilitating vital facilities and infrastructure in the camp.

Several UNRWA facilities were destroyed in the Syrian warfare and others have gone out of operation, including two clinics, a vocational training center, a youth development center, and 28 schools, out of 112 UNRWA schools in Syria, along with eight public schools.

In the meantime, residents of Daraa Camp for Palestinian refugees, south of Syria, have been grappling with a chronic water blackout, which has been ongoing from the time the opposition



outfits seized the camp until the Syrian government forces regained control over it.

The residents have been forced to drink water spouting from contaminated artesian wells or purchasing tanks at prices of up to 900 Syrian Pounds.

The residents urged the Palestine Liberation Organization, UNRWA, and General Authority for Palestine Refugees to make serious steps in order to reconstruct infrastructure, rehabilitate water, power, and sanitation networks, and restore UNRWA's health, educational, and relief facilities.

The Syrian government forces have tightened grip on Daraa residents, blocking their access to aid items and cutting drinking water for months. Civilian buildings and facilities also sustained heavy damage in the rampant shelling on the camp.

In another development, Palestinian refugee Mohamed Yehya AlBobali, aged 18, has been enduring a mysterious fate since August 15, 2011.



The Syrian authorities continue to withhold information about his condition and whereabouts.



AlBobali was a resident of AlRaml Camp for Palestinian refugees in Latakia.

AGPS documented the incarceration of 1,696 Palestinian refugees in Syrian government jails, among them 106 women and girls.
