"Two Brothers Died due to Torture in the Syrian Prisons, Unknown Groups Assassinate Activists in the Yarmouk Camp"





The two brothers "Raafat and Nawras Abdel Aal" died under torture

- Four Palestinians died in Syria including two brothers due to torture.
- Big damages due to the broke out of fire in one of the UNRWA schools in Khan Danoun.
- The relief commissions in Khan Al Shaih camp rehabilitate the damages that were resulted from explosive barrels bombing.
- Arrest campaign of a number of Al Aedin Palestinians of Syria refugee camp residents.
- The Greek authorities detain a number of Palestinians of Syria refugees.
- Distributing humanitarian aids to the Palestinians of Syria in Ein El Helwa and Antakya city in Turkey.

Victims

Raft and Nawras Abdul Aal from the Yarmouk camp were killed due to torture in the Syrian regime prisons after being arrested by members of the Regular Army Hjaira checkpoint during their departure from Yarmouk earlier, bringing the statistics of torture victims, that is documented by the Action Group for Palestinians of Syria, to 240 Palestinian victims.

Meanwhile, unknown groups assassinated two young men from the Yarmouk refugee camp, they are: "Ahmad Al-Sahli," after Al Isha prayers, the day before, in Al Orouba neighborhood, and the young man Abdullah "Abu Uday."

It is noteworthy that the Yarmouk camp in Damascus witnessed, during the past few months, the spread of assassinations and arrests phenomenon, which affected several Palestinian activists from the Yarmouk camp recently, the last one was a member of the Yarmouk gathering "Bahaa Saqer".

Recent Update

A huge fire broke out, the day before, in "Beit Lahiya" school of "UNRWA" in Khan Dannoun Camp in Damascus city. According to the reporter of the Action Group, a fire, which did not know the real reason behind it, resulted in material damages and led to the burning of most

tents, which were sheltering displaced people who live within the school, and referred that the camp receives hundreds of Palestinian families who were displaced from their camps because of the bombing and the siege.

The resumption of distributing limited amounts of aid to the trapped people of Yarmouk in Damascus, yesterday. The people were gathered near Al Righa yard to wait for their turn to get aid, and referred that the Regular Army and groups of the Popular Front - General Command impose a strict siege on the camp for the day 401 respectively, and that led to the suspension of all bakeries and Hospitals except Palestine hospital, which works with its minimum capacity because of the acute shortage of medical staff and materials.

In the same context, a state of cautious quite prevailed Khan Al Sheih camp in Damascus city coincided with the continuation of opening of "Zakia road", which is the only road that connects the camp with the neighboring areas.

Palestine Charity Committee continues cleaning and maintaining the buildings and streets, that were damaged by heavy shelling with explosive barrels, which targeted the camp a few days ago and resulted in one victim and dozens of wounded.

On the other hand, the arrest campaign was escalated, recently, by the Syrian security forces against Palestinian refugees in AL Aedein camp in Homs which caused a state of fear and tension among its residents for fear of being arrested, and mentions that Syrian security forces arrested, the day before, three of the camp's residents, they are: Jawdat Kamal, 60 years, from the city of Acre in Palestine, was arrested by members of Tadmor square checkpoint while he was returning from his job at the Education Directorate.

Greece

Dozens of Palestinian Syrian refugees who were detained on the Greek island "Simi", launched urgent distress calls, urging, through the Action Group for Palestinians of Syria, all bodies and institutions that are concerned about refugee rights, and official Palestinian institutions to

intervene urgently to put an end to their suffering, as they were arrested by Greek authorities on charges of illegal immigration. In details, 108 Palestinian refugees, including 25 children, 36 woman and a number of wounded were forced to leave their camps due to bombardment and siege and try to reach Europe, but Greek police arrested them while they were trying to travel to a European country through Greek airport, and then they were detained on the Greek island, "Simi".

It is noteworthy that there is no country in the world grant a visa for the Palestinians of Syria, forcing many of them to risk their life and travel in an irregular manner, which exposes them to fraud and swindling, or exposure to violence in the name of law and under the pretext of illegal immigration.

Release

Ali Abdullah Miari, 55 years from Al Nairab camp was released, after being arrested by the members of Ramouseh checkpoint of the Syrian regime in Aleppo, on 18/08/2014.

The Syrian security released the young man "Said Fadi Antar" after being arrested at the Lebanese border while he was returning to Syria.

Civil Work Committee

A number of food baskets were distributed, the day before, to Palestinian Syrian refugees who are in Antakya city. It is mentioned that hundreds of Palestinian Syrian families have been displaced to Turkey due to bombing and blockade, where most of them suffer from economic and legal problems, and most of them entered Turkey illegally and that because the Turkish Embassy in Lebanon refuses to give them visas to Turkish territory without giving reasons.

Palestinians of Syria in Lebanon committee at Ain Al Hilwa camp, in collaboration with Al Forqan Association, distributed about 100 food baskets to the displaced Palestinian families from Syria to Lebanon who did not benefit from the previous association aids.
