### **Recent Updates**

*Multiple sources confirmed to the AGPS that the young man, "Abdullah al-Issa," who appeared in a recording that was published by "Nour Al-dein Alzinki" group of the Syrian armed opposition groups. The group showed while they were slaughtering the young man, who is not Palestinian; he is a Syrian citizen from the city of Homs, and one of the fighters of the Syrian regime.*



*The AGPS followed up the case through its correspondents and through observing new received and published data about him. The AGPS received an image from the place his funeral as he appeared in military uniform. Webpages affiliated with the Syrian opposition published pictures of his military card with his photo and confirmed that he is 19 years old.*

*The AGPS stresses that the crime of "slaughter" that took place in Aleppo is a convicted crime and a violation of international and humanitarian law regardless of the victim's nationality.*

*It should be noted that the AGPS documented (3291) victims among the Palestinian refugees who died since the start of war events in Syria.*



*The AGPS correspondent reported that a number of residents from Nairab camp were injured by shrapnel from explosive bullets. The injuries are: Ahmed Azam, Bilal Azam, Ahmed Said Azam, and Mahmoud Azzam, noting that they were injured in the hand, foot, chest, and abdomen.*

*The location of Nairab camp which is adjacent to the Nairab military airport constitutes a strategic position for the conflict parties in Syria. The camp was previously targeted and been shot which led to a number of victims among civilians, while a number of its residents were killed due to their engagement in the war events in Syria.*



*News from the besieged Yarmouk camp reported that a woman was injured in the main Yarmouk Street with two bullets by unknown sniper. She was transferred to the medical center for receiving treatment. It is worth mentioning that snipers of ISIS and Nusra are stationing above civilians' houses, in addition to the snipers of the Syrian regime and its affiliated groups.*





*Furthermore, the regular army, the GC groups, and the pro-regime Palestinian factions continue to besiege the Yarmouk refugee camp for more than 1130 days respectively, where the water was cut off for (680) days and electricity for more than ( 1191) days. They also prevent the entry of food and medical supplies, etc., and prohibited residents to exit or enter from the main entrances of the camp which are controlled by groups of the Syrian security forces and Palestinian groups.*

*The frequent shelling and the continuous blockade led to the stoppage of all hospitals and clinics, while a number of medical staff died by bombing and mortars. ISIS breaking into the camp and imposing its control have aggravated the conditions of its residents since the beginning of April 2015, where many of the relief agencies withdraw due to ISIS threats.*



### **Lebanon**

*A number of Palestinian Syrian activists in Lebanon confirmed to the AGPS reporter that a state of anger and resentment spread among the Palestinians of Syria in Lebanon after UNRWA updated the data of the Palestinian Syrian families in Lebanon on July 25. The state of anger came following the conditions that were developed by UNRWA to update*



*those data, describing those conditions as impossible, where UNRWA requested all family members to attend personally to its statistics centers. UNRWA also requested to bring documents proving residency in Syria before March 2011, such as electricity or phone receipts, a lease, a school certificate for children, as well as other personal documents.*

*They also called for rejection of the arbitrary UNRWA's decision, according to their expression, which stated to re-registration of Palestinian Syrian refugees in Lebanon. They considered that the decision of attending the whole family with electricity and water bill carries the ultimate humiliation of refugees, stressing that as long as head of the family provides UNRWA with all identity papers, why to insist on certain conditions, which do not provide or delay in the census process.*



*In turn, the Monitoring Committee of the Palestine Syrian refugees in the East and the West Beqaa called the Palestinians of Syria in Lebanon to sit-in on the day that is determined by UNRWA for re-registration. They also demanded UNRWA to rescind these unjust conditions or to modify*



*them, as they called the Palestinian refugees not to go to the UNRWA offices, but UNRWA is the one who must go to the refugees' houses. It should be noted that the UNRWA updated the data of Palestinian refugees in Lebanon in June 2015, through field visits to their homes, and contact them by telephone.*

*Palestinian Syrian refugees in Lebanon, who are estimated with 42,000, according to UNRWA statistics, are suffering from the complex crises; the most prominent are legal and economic crises, where the Lebanese authorities have taken strict procedures against them especially with regard to their entry into Lebanon and the possibility of extending their residency.*

*Many families were dispersed because of these actions, in addition, they are suffering of high cost of living in general, and rent of homes in particular, in addition to the lack of work in Lebanon, for several reasons, including the legal situation and the spread of unemployment.*

### ***Palestinians of Syria; Numbers and Statistics till 21\07\2016:***

- *15500 Palestinian Syrian refugees are in Jordan*
- *42.500 Palestinian Syrian refugees are in Lebanon*
- *6000 Palestinian Syrian refugees are in Egypt, according to the UNRWA statistics till July 2015*
- *8000 Palestinian Syrian refugees are in Turkey*
- *1000 Palestinian Syrian refugees are in Gaza*
- *More than 71.2 thousand Palestinian Syrian refugees have reached Europe till the End of December 2015*
- *The Yarmouk Camp: siege, imposed by the Regular Army and PFGC groups, continued for 1129 consecutive days. Power cut continued for more than 1191 days, water was cut for 680 days respectively. The number of siege victims is 187.*
- *Al Sbeina Camp: - Regular Army is still preventing the residents of the camp to return back to their houses for 983 days respectively.*
- *Handarat Camp: - All Residents have left the camp for about 1 175 days after the Syrian Opposition Groups controlled it.*

- *Dara'a Camp: - It is now almost 836 days without water and almost 70% of its buildings were demolished.*
- *Jermana, AL Saieda ZAINab, Al Raml, Al Aedein Camps in Homs and Hamma: - A relatively quiet situation in light of the economic crises.*
- *Khan Al Sheih Camp: - Roads linking the camp to the city center are still closed except for Zakia- Khan Al Sheih road.*
