"A Mother and her Children Appeal for Release from the Macedonian Prisons after being detained for Three Months"



The family detained in Macedonia

- Violent clashes and shelling at the Yarmouk camp south of Damascus.
- Bombing on the vicinity of Khan AL Sheih camp and the power returns after one day cut.
- The Action Group: 39 victims from Al Aedein camp in Homs were killed since the beginning of the events in Syria.
- Free medical day for the Palestinian refugees at Baalbek in Lebanon.

Macedonia

The Action Group for Palestinians of Syria received a call from the family of Mrs. Ilham Saleh, a Palestinian refugee from Khan Al Sheih camp in Damascus suburb, was arrested with her children while trying to reach Europe through Macedonia. In details, Mrs. Ilham Saleh, 35 years, has left the camp with her three children, Hamza Saleh 9 years, Mohammed Saleh 8 years, Salah Saleh 4 years, as well as her niece Zaina Yousef 3 years in addition to a number of Khan Al Sheih residents, to reach Europe by land through Macedonia passing by Serbia.

During their journey, the smuggler's car had an accident and they have been injured, while the Macedonian police arrested them and deported most f them to the borders, but they kept the mother Ilham Saleh and her four children. The police put them in prison at the Macedonian capital Skopje and they stayed there for three months in bad circumstances with no connection with the outer world, since she could not connect with her family but two times during the whole period.



During the tow calls, the mother appealed all sides to intervene to release them and to end their suffering, she also said, "they told us that we will remain in prison till the date of the court to provide testimony against the smuggler," Therefore, the detained family expressed their concern on the mother's health inside the prison after they knew news about the bad circumstances at the prison, despite their appeal to the RC and the Palestinian embassy in Bulgaria, since there is no embassy in Macedonia.

According to her family testimony, the Palestinian ambassador visits and the meeting series he held, did not came up with any results, even the ambassador himself did not manage to meet the mother and her children. They also added that the Palestinian embassy in Bulgaria avoid their calls and concerns about their daughter and her children.

The family of the detainees renewed their appeal through the Action Group for Palestinians of Syria to all human rights organizations including RCS, Human Rights Organization, Amnesty International, Palestinian embassy in Bulgaria, PLO, and the Palestinian faction to intervene urgently and immediately to put an end to the mother and her children suffering.

Recent Updates

Heavy shelling targeted the Yarmouk camp in Damascus suburb with a number of shells at different places and resulted in a number of injuries, coincided with clashes between the armed Syrian opposition groups and members of the PFGC. Meanwhile, UNRWA resumed distributing food and medical aids to the besieged people of the Yarmouk camp which is besieged for 504 days respectively, while the camp is still without water for 74 days, which exacerbated the residents suffering.

A number of shells targeted the adjacent area of Khan Al Sheih camp, which were heard clearly inside the camp, while the power returned to the houses after being cut for 24 hours. In terms of transportations, all roads that link the camp with the surrounding areas are still closed except for Zakia road-Khan Al Sheih.

In the same context, the team of the Action Group for Palestinians of Syria announced that the number of Palestinian refugee victims from Al Al Aedein camp in Homs, who were killed since the beginning of the events in Syria, is 39 victims, including 11 were killed due to the bombardment, 4 by sniper shot, 4 by gunshot, 5 due to torture, a refugee by a car bomb, 2 were kidnapped and then killed, and a refugee was executed by white weapon.

Civil Work Committees

Free medical day were held by Palestinians of Syria Doctors (Sy.Pal.Med) at Bilal Bin Rabah hospital in Baalbek, Lebanon, a number of doctors, specialized at General, kidney and urinary tract Surgery, as well as pediatricians and internal physical therapy, have participated in this day.

Where "203" patients from the Palestinian refugees in Lebanon were examined, and necessary medicines and tests were also provided to them and conducted two surgeries (minor surgery). It was mentioned that the medical day was funded and sponsored by the "Al Wafaa European campaign", "Danish Crescent Charity" and "Al Rahma Association in Austria."

In a related context, Hemma Youth Group, in cooperation with Women Center in Khan Al Sheih camp in Damascus suburb, held a ceremony on the occasion of World Children's Day at Al Amal kindergarten of the Center, in the presence of representatives of all bodies and agencies working in the camp, and a large crowd of children and parents.

World Children's Day in Khan Al Sheih camp

The Palestinian Camps in Syria, Numbers and Statistics till 20/11/2014

- The Yarmouk Camp: Siege, imposed by the Regular Army and PFGC, continued for 504 days respectively. In addition, power cuts continued for more than 587 days, water was cut for 74 days respectively. The number of victims due to the siege has reached 157 victims.
- 41 Palestinian refugees were killed outside of Syria.
- 95 PLA members were killed due to Clashes in Syria.
- Al Husayneyya Camp: Regular Army is still preventing the residents of the camp to return back to their houses for 406days respectively.
- Al Sbeina Camp: Regular Army is still preventing the residents of the camp to return back to their houses for 375 days respectively.
- Handarat Camp: Residents have left the camp for 575 days after the Syrian Opposition Groups controlled it.
 Dara'a Camp: It is now almost 221 days without water and a complete absence of basic services.
- Khan Al Sheih Camp: Roads linking the camp to the city center are still closed except for Zakia road.
- Khan Danoun Camp: Economic crisis is still continuing, specially unemployment and high prices.
- Al Nairab Camp: Power is still cut for more than a year.
- Jermana, AL Saieda ZAinab, Al Raml, Al Aedein Ca mps in Homs and Hamma: A relatively quite situation in light of the economic crises.
