"A Child was Injured with Three Bullets due to Macedonian Police Fire on a Number of Palestinian Syrian Refugees while Crossing the Macedonian Territory"



- Shelling and clashes in the Yarmouk camp, and the water crisis is still going on for 14 days respectively.
- Deterioration of the security situation in the surrounding areas of Jaramana camp caused a state of instability and insecurity.
- Palestinian Syrian refugees detained in Greek prisons launching an appeal to intervene for their release.
- Palestinians of Syria in Lebanon sit-in to protest against the (UNRWA) financial aids cut for hundreds of families.

Macedonia

the Macedonian police opened fire on a group of Palestinians of Syria while crossing its territory to reach Europe which led to the injury of the child Mohammed Hafez Hassan, who is 13 years old with three shots, where he was transferred to a hospital "mother Teresa" for treatment in the Macedonian capital Sakbaa,. The Macedonian police also arrested a number of Palestinian Syrian refugees, Omar, Ghassan, and Mwafaq Abu Shalla.

Recent Updates

The residents of the Yarmouk camp southern Syrian capital Damascus are still suffer from the continued cut of water for the 40th day respectively, forcing them to retrieve from the areas adjacent to the camp, or stand since the early morning for hours in a queue to get some water from artesian wells in the camp.

On the field, heavy clashes broke out in the Yarmouk refugee camp between members of the (PFLP-GC) and armed groups inside the camp, coincided with the fall of a number of missiles at different places resulted in material damages, which led to the suspension of the distribution of food aid provided by UNRWA for the third day respectively.

In terms of health aspect, one of the medical staff in the Yarmouk refugee camp reported that the camp is at the gates of a humanitarian catastrophe due to the spread of communicable diseases among people as a result of lack of hygiene resulting from the continued cut of water all around the camp. In addition to the acute shortage of medicines, supplies, and medical staff, who led, in the middle of July 2014, to the injury of more than 115 people with typhoid fever as a result of the lack of necessary medicines for the treatment of this disease because of the siege that completed 429 days respectively.

On the other hand, powerful explosions rocked throughout jermana camp in Damascus city as a result of the intensification of clashes between the forces of the Syrian opposition and the Syrian regime in the areas adjacent to the camp, causing a state of panic among the population who complain of overcrowding and lack of basic services and scarcity of food, medicine and fuel.

It is mentioned that Jaramana camp receives thousands of displaced families from the Palestinian refugee camps and areas adjacent to it because of the deteriorating security situation.

In the same context, sounds of explosions and violent clashes were heard across Khan Dannoun camp in Damascus city, due to battles between the opposition forces and the Syrian regular army on the crossing of Al Tiba town adjacent to the camp.

In the meantime, the ongoing events in Handarat camp are still unclear especially after the displacement of its residents because of the continuing suffering of the bombing and the violent clashes between groups of the FSA and the regular army.

On the other hand, the residents of Handarat Camp suffer from difficult humanitarian and economic conditions due to their displacement from their camp to various places in Aleppo and the surrounding areas.

Civil Work Committees

Within the project which was launched last year under the title "I have the right to learn", Palestine Charity Committee distributed school bags to students, schools, alternative schools and crisis schools in the Yarmouk refugee camp, in order to support educational projects in the camp and equipping schools, maintenance and support educational projects and psychosocial support for the children of Yarmouk.

In turn, the Charity Commission for the Relief of Palestinian people formed a specialized team to provide psychological and social support for Palestinian children who were displaced from the Yarmouk refugee camp in the Syrian capital Damascus, in an effort to mitigate the effects of the Syrian crisis that has cast a shadow on the Palestinians in Syria.

As in Lebanon, the Commission of Palestinians of Syria in Lebanon, in cooperation with the Palestinians of Syria workers gathering on 21/September, carried out a restoration project for AL Bahaa kindergarten shelter at Ain al-Hilweh camp, homed by 40 Palestinian families coming from Syria. The restorations included all health facilities, installation of a pump and a water reservoir, extensions of electricity and health, paint the walls and maintenance.

It is noteworthy that this project comes within the framework of the efforts made by the Commission of the Palestinians of Syria, in Lebanon, in order to provide basic services to all centers and communities inhabited by Palestinians of Syria in Lebanon and secure a decent life for them until their crisis solve.

Lebanon

A number of Palestinians of Syria refugees in Lebanon carried out yesterday a sit-in in front of the UNRWA office in Sad Nabel area in Beqaa Alawsat protesting on the UNRWA decision of the financial aids cut of 1200 Palestinians of Syria families in Lebanon. The protestors demanded the UNRWA to return back on its decisions and should take the humanitarian and legal responsibility towards the refugees.

Greece

Palestinian refugees detained in Greek prisons, launched, through the Action Group for Palestinians of Syria, appeal of human rights institutions and civil society to intervene for their release after being arrested by Greek authorities on charges of illegal immigration. In details, about 120 Palestinian Syrian and Syrian refugees were detained by Greek authorities about a month ago on charges of illegal immigration while trying to travel to Europe via its airport, and detained them at (Makdeniza Camp) in (Maneyadi) area in Athens, they are living in dire conditions and harsh circumstances.

Accordingly, the Palestinians of Syria decided to announce indefinite hunger strike in a protest at their continued detention in inhumane conditions and the injustice done to them, and they are fleeing from the hell of the conflict in Syria.

A number of activists and social networking pages (Facebook) launched a campaign of solidarity with the Palestinian and the Syrian prisoners intended to highlight the suffering in Greek prisons and calling for urgent action in order to release them.

In turn, the Action Group for Palestinians of Syria denounced continued detention of the Greek authorities for Palestinian and Syrian refugees and demanded the (UNHCR) to shoulder their responsibilities towards them, considering the Greek authorities conducting with refugees fleeing the war in this manner contrary to international law and international norms.

Boats of Death

The Action Group received news about a trading vessel, which raises the Singaporean flag, rescued 55 people including Palestinians of Syria and Syrian refugees after the ship received information from the Italian Coastguards about the place of the Death Boat. The Italian mass media informed that the boat was carrying 100 survivor refugees.
