“Explosive Barrels Targeted Dara’a Camp and a Palestinian Killed in Syria Raising the Number of Torture Victims to 214”



The effects of shelling Daraa camp

- Yarmouk residents claim all the signatories to the camp neutralization agreement to implement all its items immediately.
- Release of ten Palestinian refugees from the prisons of the Syrian Regime.
- Thirty Palestinian Syrian refugees appealed to the Tunisian government to give them temporary residence in its territory.
- Palestinians of Syria in Lebanon demand UNRWA to take humanitarian and legal responsibility towards them.
- Human rights activists on hunger strike in solidarity with the Palestinian refugee "Rakan Hussein".

Victims

Mohammed Issa Abu Hassan was killed under torture in Syrian prisons, after being arrested for more than five months.

Thus, Action Group for Palestinians of Syria has revealed that 200 Palestinian refugees died under torture since the beginning of the conflict in Syria.

The group said that during June 2014 fourteen Palestinian refugees were killed under torture, raising the number to 214 victims.

The group explained that most victims' bodies have not been handed over to their relatives. They contacted only one of the family members of the victim to inform him to go to the security station to receive the victim belongings, without allowing them to ask about his body.

The Action Group for Palestinians of Syria renews claiming the Syrian regime to disclose the fate of hundreds of Palestinian prisoners who are considered in unknown places. The Action Group stressed on that what is happening inside Syrian prisons for Palestinians is a war crime with all standards.

Recent Updates

Influx of large numbers of people from Yarmouk camp south of Damascus to Al Rija yard since the early morning , hoping to apply the terms of the agreement, which was agreed upon two days ago to break the siege and to return people to their families.

Nothing of the initiative items has been applied on ground, In light of contradicting news about the real reason behind the non-implementation of the agreement.

For their part, a number of activists issued a statement on behalf of the people of Yarmouk, Action Group received a copy of it, which carried all the signatories of the agreement, including the Syrian State, full



responsibility for the implementation of all items and judging obtrusive parties.

The statement issued by the activists of the Yarmouk refugee camp

The statement stressed on the need to accelerate the application of the agreement terms and not manipulate the fate of the Palestinian people inside Yarmouk, and to open the road immediately in front of the entry and exit .

The statement also called on the armed groups inside the camp to respect the agreement and seek to apply it.



In the south of Syria, explosive barrels targeted Dara'a camp which led to a massive destruction in people's homes.

In the same context, people of Dara'a camp live a state of fear and panic because of the intense prevalence of snipers in the areas bordering on the camp streets, resulting in the siege of the camp and the inability of the people there to move freely for fear of being targeted by snipers who shoot anything moving in the streets.

People of Dara'a camp still suffering of life conditions, especially with the acute shortage of medical supplies in the camp.

On the other hand, the residents of Al Raml Camp live a stressful economic crisis as a result of the deteriorating security situation in Syria, manifested high cost prices, widespread of unemployment and scarcity of food and fuel.

Warplanes hovered above Khan Al Sheih camp in Damascus city, yesterday, coincided with violent explosion voices caused by the bombing of the surrounding areas.

It is worth mentioning that the camp is suffering from multiple crises, especially in the sides of living and health, in addition to the continuation of power and communication failure for long periods.

Tunisia

Thirty Palestinian Syrian refugees, resident in tourist school "Karkouan" in Al Hamamat Nabel area, appealed to Tunisian authorities to grant them a temporary residency and demanded the restoration of all their papers in order to get freedom of movement on the Tunisian territory.

It is worth mentioning that the airport authorities in Tunisia had been detained those refugees in Carthage International Airport at transit area and prevented them from leaving until being deported to Beirut, which was the their first travel launching.



After the intervention of several international human rights organizations and Tunisian mass media, Tunisian Internal has issued decision to allow them to enter into Tunisian territory, while allowing them to stay for a period of one month, and states that the main destination for detainees was Libya, but the planes were forced to divert to Tunisia..

Lebanon

A number of Palestinian refugees, coming from Syria to Lebanon sit-in on Monday 23rd June, in front UNRWA office at Saad Nail area in the region of Bekaa center, to protest against the decision issued by the Lebanese government. The decision is to prevent the entry of Palestinian Syrian refugees to Lebanese territories except under the visa and prior approval, and stop renewing their residency permits.

They also called upon UNRWA to increase monthly aid, and to carry humanitarian and legal responsibilities.

Hungary

Migszol "human rights group" in Hungary, issued a statement announcing hunger strike of a number of activists in solidarity with the Palestinian refugee "Rakan Hussein" who is on hunger strike since twelve days in Hungary protest against the obstruction of the Hungarian authorities to reunite with his children on the pretext of not recognizing their Syrian passports.

Migszol group explained in a statement the harsh conditions suffered by Hussein caused by the death of his wife and his mother with explosive barrels in Syria, and put him away of all his children.

The group also criticized the Hungarian authorities actions and unfair laws, which violate the agreement of the European Union and the way of dealing with Hussein issue and the Hungarian situation about the Palestinian Syrian passports.

It is worth mentioning that Migszol group had connected with UN High Commissioner for Human Rights UHCHR and Helsinki in Hungary in order to resolve the issue of Rakan Hussein as soon as possible.
