Victims

Anas Al Khatib from the Yarmouk camp was killed due to torture in the Syrian Regime prisons, where the Syrian regime handled the victim's personal identity to his family after arresting him for 6 months. Salah Qareesh 40 years from Rokn Al Dein compound was killed due to torture after being arrested for 18 days which raises the torture death toll, that the Syrian Security told their families of their death, this month, to 23 Palestinian refugees. Baker Qassem from Jermana camp was killed due to the ongoing clashes in Syria.

Recent Updates

The Yarmouk camp was exposed to bombing by shells in the vicinity of the main street. The shells caused material damages in buildings and properties without injuries. It was heard sounds of clashes with heavy and light weapons. It is referred that the Regular Army and the PFGC, which are imposing a strict siege on the camp since more than 400 days, allowed the entry of a limited food aids to the camp and was distributed to the residents.

In Damascus city, the surrounding farms in Khan El Sheih camp were exposed to a number of shells coincided with a calm state in the camp. The camp suffers of a severe shortage of the medical care because the difficulties to reach the medical materials to the camp, In addition to the absence of the medical staff where the UNRWA clinic that provides simple medical care is the only medical clinic in the camp.

IN Lathekia, the Syrian Security arrested Mari Kali 59 years from Handarat camp and was displaced to Al Raml camp in Lathekia after the control of groups of the Syrian opposition on it.

On the other hand, the Egyptian Authorities arrested dozens of Palestinian and Syrian families in charge of illegal migration to Europe, as they were arrested in inhumane conditions and the authorities put them in narrow rooms though they are a big number, without taking into consideration the health conditions. It is mentioned that the Egyptian Authorities arrest the Palestinian and Syrian refugees frequently during their trials to reach Europe through Egyptian beaches.

It is referred that the living and legal status for the Palestinians of Syria and Syrians who are in Syria, Lebanon, Egypt and Turkey pushes them to try to reach European countries which provide them the proper legal status and living conditions.
