#### Lebanon

The survey detachment in North Lebanon arrested 107 Palestinian Syrian and Lebanese refugees on the shore of Tripoli Port while they were trying to illegally immigrate through Lebanon toward Italy. For its part, Lebanese security arrested one member of the network, a Lebanese named (F.A), who admitted that the network in which he works overcharged \$6,000 for each person and \$2,000 per child, and added that they promised the passengers to transfer them in a small boat to outside the territorial waters and then transported by another big boat toward Italy.

#### **Victims**

The Young man "Firas Hassan" from the Palestinian Liberation Army and from Khan Al Sheih Camp was killed due to clashes between the Syrian opposition forces and the regular army troops supported by from the Palestinian Liberation Army.

#### **Recent Updates**

Handarat Camp in Aleppo, which is under the control of the Syrian opposition forces, was targeted yesterday by explosive barrels and a number of missiles at different places him, causing material damage to the homes and property of the people, referred that most of the people in the camp had fled because of frequent clashes and shelling.

In the meantime, the main street in the Yarmouk camp south of Damascus was exposed to sniper which resulted in a state of fear among the residents, coinciding with sounds of sporadic clashes in Al Tadamon neighborhood next to the camp. On the other hand, the Action Group received reports about the departure of a delegation from the camp included six people to discuss the issue of breaking the siege of the camp to neutralize it, as also reported by the information that the delegation returned to the camp without declaring any information about the substance of what has been reached of agreements and talks between the two parties.

Meanwhile, the residents of the Yarmouk refugee camp suffer, for the sixth respectively, of the continuation of water cut all around the camp, in addition to deprive them of receiving food aid from UNRWA for the fifth day respectively, due to the clashes and sniping at Alrija yard and Rama Street in the past days, adding to the deterioration of their living conditions which led to the spread of chronic and infectious diseases.

In a related context, powerful explosions rocked Khan AL Sheih camp in Damascus city by the bombing of areas and farms surrounding it, while the residents complain of the closure of Zakia -Khan Al Sheih road because of shelling and sniping, what constitutes a threat to the people of the camp who many of them was killed as a result of targeting them on this road.

The residents of AL Raml camp in Latakia West Syria, which receive a large number of displaced from the Palestinian refugee camps and neighboring areas due to the deteriorating security situation, lives a state of relative calm, comes in the light of the continued economic suffering that in the manifested scarcity of food, medicines, fuel and high prices, and the continued power cut for more than 12 hours a day.

#### **UNRWA**

According to Relief and Works Agency for Palestine Refugees (UNRWA), the number of displaced Palestinian Syrian refugees in Lebanon reached (44000) refugees, according to the latest statistics conducted by the staff in July 2014 in order to collect data about the social and economic situation of each family of Palestinians in Syria, which cutting off cash assistance for about 1,100 families.

In the context of the move against the last decision of UNRWA about the cut of cash assistance for hundreds of families of Palestinian starting from October 2014, the representatives of the civic Committees, displaced and the Palestinian factions held a meeting yesterday with the Director of the Regional Office for (UNRWA) in Beirut, to discuss its recent decision to cut off cash assistance for hundreds of displaced Palestinian Syrian families in Lebanon, and claim to backtrack on this unjust decision towards the displaced families.

In turn, the Deputy Director-General of UNRWA stressed that this decision was based on internationally recognized criteria, and confirmed that all the families affected by this decision have the right to appeal, if they wish, within three weeks to be studied by them, also expressed the commitment of UNRWA to continue to provide services to Palestinian refugees in a way to ensure the sustainability of services, especially to those most in need.

For their part, the representatives of the civic Committees, displaced and the Palestinian factions accused UNRWA of procrastinate, and evasion of responsibility for legal and humanitarian obligations towards the Palestinians of Syria, and therefore called for a sit-in on Thursday, 25 / September in front of the regional office of UNRWA in Beirut and Al Borj AL Shamali camp to denounce this decision.

A delegation of Hamas movement in Lebanon visited the UNRWA Office and met with Director General of the IAEA, "Ann Desmor" and discussed with them the situation of Palestinian refugees in Lebanon, also discussed the issue of stopping UNRWA payment of financial aid for a number of Palestinian Syrian families displaced to Lebanon. Hamas delegation expressed their reject for this procedure, demanding UNRWA to assume their humanitarian, legal and material responsibilities towards the Palestinian Syrian refugees displaced to Lebanon pending their return till their problem solved and return to their camps in Syria and then to their homes in Palestine.

### **Italy**

The Action Group received reports that the Italian authorities had deported 726 immigrants yesterday, most of them Palestinians of Syrian, Syrians and different nationalities from the south of Italy to the north, in order to alleviate the large number of migrants in the coastal area and make room for the reception of more illegal immigrants.
