"Medical Negligence Threatens the life of PRS Child Jawad

#### **RECENT UPDATES**

Mother of the child "Jawad Al-Abweini" appealed to the human rights organizations, Child rights organization and the UNCEF for rapid intervention to rescue her son's life. The 7-year-old child who is detained in one of the refugees' camps in Greece has chronic disease in his head and needs special medical care which cannot be secured in such places.

Qinaz Al-Nabulsi, the mother, said the illness of her child started in Syria where he inhaled gases fired at Al-Hajar Al-Aswad town in Damascus Countryside. The pathological case worsened due to the siege imposed on Al-Yarmouk camp where they were living, the



child could not get the necessary medical care, this leaded to Cerebral Palsy, underwent a surgery afterwards subjected him to a severe bleeding.

The continuous deterioration in his health condition pushed the family to move to Lebanon, before they risk their lives and to arrive to Greece hoping to reach western Europe countries where Jawad can get the proper treatment, according to the mother.

Mrs. Nabulsi says "We were shocked by way Greek police treated us, together with thousands of refugees, the police carried out a systematic humiliation against us, their behavior was incompatible with human rights norms and laws. They are using us as leverage in order to earn

money from the European Union without taking into account the situation of children and the sick people" according to her.

Mother of the sick child says she appeals to all Palestinian Parties and Organization as well as to the Palestinian Embassy in Greece, and to the UNRWA and Child rights organizations for rapid intervention to rescue her sick child before it is too late.

On the other hand, the remaining residents inside the Al-Yarmouk camp, who are estimated at 3.000-5.000, are suffering from a severe shortage in medical supplies and medicines, due to the continuing siege by the Syrian Regime and the PFLP-GC for 1016 days. However, situation worsened after ISIS broke into the camp and forced most of the relief foundations to stop since April 2015.



In Homs City, residents of Al-Aydeen Camp complain about the choking and abusive practices of the regime's forces against them, all roads and entrances to the camp were closed except the main entrance. Sand berms and concrete barriers have been installed between the camp and Al-Shammas area, barbed wires between the camp and Damascus road, in

addition to the ironic fence that separates the camp from the rest of the surrounding areas.

On its turn, the security forces and its affiliated groups carried out storming and arresting raids, forced the Palestinian youngsters to join the military service, while in other cases evicted tenants and expelled them out of the camp despite holding valid renting contracts.



These security practices have left heavy impact on the daily life of Palestinians inside the camp, prices increased significantly due to the bribes and royalties paid to the soldiers and checkpoints.

In Hama City, the monitoring and documentation team of the AGPS has documented names of 20 victims from Hama camp, 3 of them killed by sniper shots, 8 by gun shots, 2 by a car bomb, 4 tortured to death, 2 were kidnaped then killed and 1 was executed in the field.

Those victims were killed due to ongoing war between March 2011 and March 2016.

### Palestinians of Syria in numbers and statistics Until 25 March 2016

- 15,000 Palestinian Syrian refugees in Jordan,
- 6,000 refugees in Egypt, according to the UNRWA's statistics till July 2015.
- More than 71,200 Palestinian Syrian refugees have arrived Europe until the end of December 2015.
- The Yarmouk Camp: still under siege imposed by the Syrian Regime's Army and PFLP-GC (Popular Front for the Liberation of Palestine General Command), continued for 1014 days respectively. In addition, power cuts continued for more than 1075 days, water cut for 563 days. The number of victims due to the siege has reached to 186 victims.
- Al Sbeina Camp: Syrian Regime's Army still preventing the residents from returning back to their houses for 870 days respectively.
- Handarat Camp: All of its residents have left the camp for 1061 days after the Syrian Opposition Groups controlled it.
- Dara'a Camp: Running water cut continues for 724 days, and 70% of its buildings were destroyed.
- Jarmana, AL-Saieda Zainab, Al-Raml, Al-Aedein Homs and Al-AedeinHama: A relatively quiet situation in light of the economic crises.
- Khan Al-Sheih Camp: Roads linking the camp to the city center are still closed except for Zakia-Khan EShieh road.
