"In a new crime against children .. The regime forces kill Palestinian child "Rami Salman" from Yarmouk camp in cold blood"

Victims

Palestinian child "Rami Mohammed Salman" his died on the hands of members of the "cruel" Syrian regime army, at the entrance of the destroyed Yarmouk camp. This occurred after a skirmish between the child and a member of the



regime, who prevented him from entering the camp yesterday, and over his objection to the continuous looting of the regime's forces.

Sources close to the child told the Action Group that the members of the regime killed their son in cold blood at the Tabah checkpoint of the regime forces, in front of the sight of a number of residents of the camp and members of the pro-regime Palestinian groups.

This is the second victim in Yarmouk camp to be killed by the cruel forces of the regime since it took control of Yarmouk camp. Yesterday Palestinian child, "Mahmoud Bakr," was killed after he tried to prevent members of the regime from looting the contents of his house in Al-Orouba Street, in Yarmouk camp.

Latest Developments

The Syrian opposition factions in south Syria published a video showing a number of members of ISIS who were arrested after leaving Yarmouk camp, according to an agreement between the



regime and ISIS, which ended with the regime imposing its control on Yarmouk camp and Al-Hajar Al-Aswad neighborhood.

According to the video published by the factions, the Martyrs of Freedom Group, the Ahrar al-Sham Islamic Movement, and the Brigade of Mohagreen and Ansar, were able to arrest two members belonging to ISIS in Harak city, whom the Syrian regime had facilitated their passage from Al-Hajar Al-Aswad to the neighboring freed areas of the eastern suburbs of Deraa.

According to the confessions of one of the members, "there was a barrier between the organization and the regime that was entering them food. In addition, copper was sold through it to the regime and ammunition was brought in to ISIS in cars. He also noted that the Syrian regime's aircraft threw ammunition and funds for the organization during the siege."

The member pointed out that the injured were being treated at Al-Mahayni Hospital, located in Al-Midan, which is completely controlled by the Syrian regime.

The confessions of the members of ISIS intersect with the information transferred by activists in the south of Damascus, which confirm that the members of ISIS received treatment at Al-Mahayni Hospital.

In a similar context, the Tawakulna Damascene family appealed to the residents of Yarmouk camp, the Civil Defense and the Red Crescent, to know the fate of their elderly father,



Mohammed Zuhair Tawaklana, Abu Bakr and his wife, after having lost contact with them during the recent Yarmouk camp events.

The missing old man's expatriate sons from Syria several years ago, said that they lost news about their father, after he stayed at his home at Lane 9 Beer Al-Sabaa, in the devastated Yarmouk refugee camp. His fate is unknown until now, and he is from Damascus living in Yarmouk camp since the years before the war.



Meanwhile, Palestinian refugee "mindless" "Eissa Yehia Abu Zeid," was subjected to hitting and torture on the hands of the Nisreen Street Groups, loyal to the Syrian regime, and a number of the residents of the neighborhood, after accusing him of belonging to ISIS.

According to the residents of Yarmouk camp, Palestinian man "Eissa" or "Abu Al-Eis," is known in his Palestinian society that he has mental disorders since birth, and was used during the siege of the camp, to wearing loose clothes and sitting on one of the roads in the neighborhood of Al-Magharba, looking to passers-by and asking them when the siege will end and when he will leave from the region.



As the Syrian regime entered Yarmouk camp, Essa was arrested on charges of ISIS and he was transferred to Al-Tadamon neighborhood. A video shows the young man in Nisreen Street, being beaten and insulted, in the presence of members of the Syrian regime, despite the knowledge of the people of the region that he lost his mind. His fate is unknown until now.



In a similar context, Talal Najy, Assistant Secretary-General of the Popular Front for the Liberation of Palestine-General Command, told a Lebanese media outlet that the armed men of ISIS, Al-Nusra and the Liberation Army, dug up an old cemetery in Yarmouk camp in Syria, in search for the remains of Israeli soldiers who were buried there in return for the occupation.

In 1982, a battle took place in the area of Sultan Yacoub in Lebanon, where a number of Israeli soldiers were killed and their remains were transferred to Yarmouk refugee camp, where they were buried in the old martyrs' cemetery. He noted that the armed men of ISIS, Al-Nusra and the Liberation Army, conducted a search for the



remains of Israelis in the cemetery mentioned by order of the leaders of the Zionists to transfer their remains to Israel.

The cemetery of martyrs in Yarmouk camp had been attacked by the members of ISIS, who earlier this year destroyed the tombstones on the one hand, while the cemetery was subjected to heavy shelling with warplanes and artillery shells by the army of the Syrian regime on the other hand.

Local Work Committees:

As part of the Social Welfare Program projects, the Charitable Association for Palestinian Relief set up an Iftar gathering for the orphans and their families, in the Qodseya area - Jaffa Foundation for Social Development, in the suburbs of Damascus. The Iftar included recreational activities and child support programs.

The Palestinian refugees in Syria suffer from extremely harsh living conditions due to the ongoing war and the displacement of tens of thousands of them, widespread unemployment, lack of financial resources, high prices and high rents.

Palestinians of Syria: May 26, 2018 Statistics:

- The total number of victims documented by the Action Group is 3761, including 466 women
- 1677 Palestinians are locked up behind Syrian government's bars, 106 of which are women
- Yarmouk refugee camp is under the Syrian regime army and Popular Front for the Liberation of Palestine's siege for 1,772 days in a row
- 206 refugees, mainly in Yarmouk Camp, have died due to lack of medical care and malnutrition
- Water supplies have been cut off Deraa Camp for 1507 days, and 1356 days in Yarmouk Camp
- The Regime army has been in control of Handarat camp for more than 603 days. More than 80% of its buildings have been completely or partially destroyed.
- Approximately 85 thousand Palestinian-Syrian refugees fled to Europe by the end of 2016, while 31 thousand refugees are estimated to be in Lebanon, 17 thousand refugees are sheltered in Jordan, 6 thousand refugees are in Egypt, 8 thousand refugees are staying in Turkey, and one thousand Palestinian-Syrians are in Gaza.
