"Activists: 80 Percent of Sbiena Camp Houses Are Almost Completely Destroyed"

RECENT UPDATES

Few activists who managed to enter Sbiena camp recently, confirmed that around 80 percent of the camp's houses and properties are almost completely destroyed, specifically, the area between Muaz Bin Jabal mosque down to Al-Akrad Bakery, which constitutes the western entrance of the camp. As for the rest of the camp they said the area is in a better condition but still needs reparations.

Houses of those who are affiliated to the opposition forces are either destroyed or burned down, activists confirm.



The regime's army and its affiliated groups are still preventing residents from returning to their houses since 7 November 2013, when the regime imposed full control over the camp following violent clashes with the opposition.

In Homs city, the AGPS correspondent, in his report about the medical condition inside the camp, said that the residents before the war used to benefit from the governmental services outside the camp, in addition to

the UNRWA clinic and the Palestinian Red Crescent's well-known hospital of Bissan inside the camp.

The corresponded added "there were six clinics inside the camp provides medical care for different fees" while statistics from the field indicated that the total number of Physicians inside the camp was 37, in addition to 20 nurse, and tens of different medical staff.

During the current war, and due to the high risk of transportation around the city, people depended completely on medical centers remaining inside the camp, which are the UNRWA clinic and Bissan Hospital only, while the private clinics, which decreased significantly, were not an affordable choice to most of the residents.

Moreover, the correspondent assures that the majority of the camps' doctors had fled the country towards Europe due to the persecution and security harassments.

In south of Capital Damascus, the family of the kidnapped activist "Mohammad Al-Mawid" from Al-Yarmouk Camp, renewed its appeals to reveal the fate of its son who has been kidnapped since the 1st of February 2016.

The family asked for any piece of information that could help finding their son, pledging to maintain the confidentiality of any contributor.

Al-Mawid, a humanitarian activist in Al-Yarmouk camp, and a volunteer in the Palestinian Red Crescent Association, is still detained under unknown circumstances regarding the kidnappers' identity and the place of detention.

Meanwhile, the Charity
Association for the relief of the
Palestinian People held medical
awareness activity in Al-Falujah
School in Al-Yarmouk Camp.



The activity aims to raise

awareness about mouth and teeth health, and the general health habits for the children in terms of treatment and prevention.

The activity included distribution of teeth-care supplies to around 700 students from the camp.

In a different topic, the Monitoring and documentation team of the AGPS said the number of Palestinian victims from Khan Eshieh camp has reached 148.

Victims were killed since the beginning of war due to the following reasons: 61 due to shelling, 29 due to gunshots, 4 due to snipers, 23 were tortured to death, 12 were kidnapped and killed, 6 drowned in the sea, 4 due to a car bomb, and 1 was executed in the field.

Palestinians of Syria in numbers and statistics Until 27 March 2016

- 15,000 Palestinian Syrian refugees in Jordan,
- 6,000 refugees in Egypt, according to the UNRWA's statistics till July 2015.
- More than 71,200 Palestinian Syrian refugees have arrived Europe until the end of December 2015.

- The Yarmouk Camp: still under siege imposed by the Syrian Regime's Army and PFLP-GC (Popular Front for the Liberation of Palestine General Command), continued for 1016 days respectively. In addition, power cuts continued for more than 1077 days, water cut for 565 days. The number of victims due to the siege has reached to 186 victims.
- Al Sbeina Camp: Syrian Regime's Army still preventing the residents from returning back to their houses for 872 days respectively.
- Handarat Camp: All of its residents have left the camp for 1063 days after the Syrian Opposition Groups controlled it.
- Dara'a Camp: Running water cut continues for 726 days, and 70% of its buildings were destroyed.
- Jarmana, AL-Saieda Zainab, Al-Raml, Al-Aedein Homs and Al-AedeinHama: A relatively quiet situation in light of the economic crises.
- Khan Al-Sheih Camp: Roads linking the camp to the city center are still closed except for Zakia-Khan EShieh road.
