



## "10 PLA Fighters Missing, 15 Others Wounded in Syria"

- Khan Eshieh Residents Launch Cry for Help over Bread Dearth
- 690 Homes in AlTadhamun Fit for Human Habitation
- 27 Palestinians Assassinated in War-Torn Syria



## **Latest Developments**

The Palestine Liberation Amry (PLA) announced that 10 fighters have disappeared while 15 others sustained wounds as they fought alongside the Syrian government forces against ISIS militias in the vicinities of Teloul AlSafa town, in AlSweida's eastern desert, south of Syria.

A document signed by the director of AlQadisiya Forces clinic and released by pro-PLA sources cited the names of 15 injured gunmen. The latter were granted sick-leaves of three to 20 days.



The list also included names of ten fighters who have gone missing in raging hostilities: Muadh Abdul Al, Amar Issa, Thaer Saleh, Mahmoud Ahmad, Hekmat Issa, Youssef Khuza'I, Tawfiq Kasem, Ouways Mawed, Sa'id AlAsta, and Basel Yahya.

A couple of days earlier, the PLA lamented the death of Walid Mer'I AlKurdi, the commander of Saeka 412 Brigade, along with officer Abdul Karim Melhem Ali. Both were killed while fighting alongside the Syrian government forces near Taloul AlSafa.



261 PLA fighters have been pronounced dead all the way through the seven-year warfare in Syria, according to AGPS data.

Meanwhile, residents of Khan Eshieh Camp for Palestinian refugees, in Rif Dimashq, have appealed to the concerned authorities and development committee to work on supplying civilians with much-needed bread and increase bread and flour quantities allotted for AJalil Bakery.

The residents said the camp's sole bakery—AlJaleel—has been operating just for a couple of hours daily, forcing civilians to walk for long distances to fetch bread loafs.



They called for reconstructing local bakeries, which have been severely damaged by violent onslaughts launched by the government forces over the past few years.

Survival for the majority of Palestinian families in war-stricken Syria has largely hinged on UNRWA aids.

In the meantime, the committee of Damascus governorate said 690 homes in AlTadhamun neighborhood, which used to shelter hundreds of Palestinian families and thousands of Syrian

nationals, have become habitable, pending the rehabilitation of other houses in line with Law No. 10 which might take up five years to materialize on the ground.

The committee said cautious measures will be taken to hand over rehabilitated homes to their owners and former residents after authentication documents are presented by the latter.

The committee added that the other homes are uninhabitable and, thus, civilians cannot be allowed in and that the land lots will remain the property of their former owners. However, no reconstruction works are allowed on them.

On April 2, a so-called Law No. 10 of 2018 was passed by Bashar AlAssad's government to organize ownership and reconstruction following a bid put forth by the Local Administration and Environment Ministry. The law is an extension of a legislative decree passed in 2012 (Decree 66).

Along the same line, AGPS documented the death of 27 Palestinian refugees as a result of abrupt assassination in warragged Syria.

The list includes 18 Palestinians from Yarmouk Camp, among them activists, journalists, and relief officers.

The casualties are: Bahaa Saker, Namer Hasan, Feras AlNaji, Yehya Horani, Mustafa Sharaan, Hesham Zawawi, Mohamed Kasem Tirawiyeh, Mohamed Arisheh, Abu Ahmed Hawari, Bahaa AlAmeen, Abdulllah Rezeq, Ali AlHaja, Abdullah Bader, Ahmed AlSahli, Abu AlAbd Khalil, Abdul Nasser Makari, Abu Dia Amara, and Mahmoud Haitham Akila.



As a result, several relief institutions and activists operating in the camp have fled the area for fear of being gunned down or executed by warring militias.

Saber AlMesri and Ahmed Nassar were also assassinated in Daraa Camp while Ahmed AlRamah was assassinated in AlMuzeireeb. Khaled AlKhalidi was gunned down in Khan Eshieh Camp; Kamal Ghanaja in Qudsaya; Reda AlKhadra in Qatna; Udwan Shehab in Saasa' in Rif Dimashq; Kamal Ghanaja in Qudsaya; and Palestinian girl Asmaa Abu Bakr in AlMezzah in Damascus. Mohamed Rafe' also appeared on the list.
