Victims

The Palestinian refugee Mohammed Mahmoud Fantazie, 44 years, from Daraa camp died due to torture in the prisons of the Syrian regime after being detained for about 4 years. It was mentioned that he was arrested on 30-11-2011 by the members of a Syrian security checkpoint at the western area in Deraa. According to some activists, the Syrian security forces



delivered his ID to his family on 25-5-2015 after they reviewed Sednaya prisons then the military security. After his family reviewed the prison they were informed that their son died on 16-2-1015, and his body was not delivered yet.

Recent Updates

9 Palestinian refugees were arrested since the beginning of May; they are:

Amjad Mohammed HAdba, AlaaAldein Ahmed Faris, Zeyad Mohammed Ayoub, Mahmoud Eisa Abbas, Amer Talib Darweesh, Mohammed Ismael Omar, Sulaiman Al Shabti, Abdu Ghannam, who was released later, Louay Hussein Mahmoud, Omran Khalil Darweesh, 17 years, who was arrested the day before by the Syrian security services by the so-called the camp security detachment.

It was noted that the AGPS has documented 117 detainees from Al Aedein camp, while the total toll of the detained Palestinians since the beginning of war events, and who were documented by the AGPS has reached 875, and their fate is still unknown.

On the other hand, number of activists and dignitaries of Sbeina camp renewed their demands of their return to their houses and properties, especially that the regular army and the affiliated Palestinian groups are controlling the camp for 561 days.

It should be noted that the camp was under a strict siege within the blockade imposed on the southern region of Damascus with the beginning of 2013, which forced many of its residents to flee to neighboring areas such as Sehnaia and Kiswa areas.

Additionally, the continuous displacement to Khan Al Sheih and Khan Dannoun camps with the intensification of siege until the camp has become almost empty, especially after direct exposure to shelling for several times.

In the meantime, clashes broke out in Yarmouk at Al Rija square between ISIS and the Regular army alongside the affiliated Palestinian groups, coincided with shelling and mortar shells that targeted Al Thalthein Street.

In the same context, residents of Yarmouk removed some of the rubble of destroyed houses by explosive barrels on the day before yesterday, which resulted in massive destruction in the place of the crash, which killed one person and a number of civilian casualties.

On the other hand, residents of Khan Dannon camp are suffering of instability state due to rising hostilities pace in the adjacent regions and towns between the Syrian opposition forces and the regular army, and the participation of some of its residents in fighting alongside the regular army, which made the camp vulnerable to shelling at various places that led to many victims and wounded.

Considering the geographical position of Khan Dannun camp, the regular army tightened its security control on the entrances and exits, and placed a checkpoint on the main gate, while residents are complaining of the practices of the checkpoint's members toward them, though a large number of youth volunteered in different groups loyal to the Syrian regime.

In Damascus suburb, Zakia-Khan AL Shieh rood, which is the only road that links the camp with the Syrian capital, is still poses a real threat to the residents of the camp, because of continued exposure to shelling and targeting with missiles, machine guns, and sniper fire.

Moreover, on 14th of May the Syrian regime forces target a civilian car was carrying number of refugees during their passage through the way of death leading to the camp, which resulted in at least five victims, including the young woman "Falastein," her brother "Mohammed Saeed Fayez Saleh," their mother "Khaldia Fayez Zahir," and the driver "Khalid Al Ramli, "in addition to a number of casualties.

Many residents of Khan Al Sheikh camp were arrested by the Syrian regime checkpoints in Artozand the entrance of Khan Al Shieh camp.

It is worth mentioning that all people in the camp are forced to take the path of "Zakya— Khan Al Shieh" despite the risk after the regime forces closed all roads linking the camp and the capital Damascus.

UNRWA

UNRWA announced that it will conduct a data auditing process for Palestinian refugees residing in Syria during the distribution of financial aid in the second session of 2015.

UNRWA said that the aim of this procedure is to ensure that all beneficiaries of financial assistance are in Syria, as it will update the data of beneficiary families in Syria, confirming that these procedures will be implemented on 31st of May 2015.

UNRWA imposed conditions for the delivery of financial aid to Palestinian refugees in Syria, and said that all family members aged 18 years and above and able-bodied to come personally to the distribution centers of cash assistance to receive financial assistance.

Meanwhile, people who are unable to come personally to submit a medical report from UNRWA clinics exclusively, and noted that if all family members aged 18 years and older and did not attend to the receiving centers will not receive financial assistance.

It is noteworthy that UNRWA is trying through its actions to reduce financial aid to Palestinian Syrian refugees in the absence of thousands of Palestinian families, between arrests, displacement, wanted by the Syrian security, and those who are besieged inside their camps.

Numbers and Statistics till 27/5/2015

- Thousands of Palestinian refugees escaped from Syria, including 10,687 refugees in Jordan, 51300 refugees in Lebanon, and 6,000 refugees in Egypt, according to the UNRWA's statistics till February 2015.
- At least 27933 Palestinian Syrian refugees have reached Europe during the last 4 years.

- The number of Palestinian detainees who were documented by the AGPS has reached 869 detainees, and 391 victims were killed due to torture in the Syrian prisons.
- The Yarmouk Camp: Siege, imposed by the Regular Army and PFGC, continued for 699 days respectively. In addition, power cuts continued for more than 769 days, water was cut for 259 days respectively. The number of victims due to the siege has reached to 177 victims.
- 80,000 Palestinian Syrian refugees escaped from Syria to the neighboring towns, including 10,687 refugees in Jordan, 51,300 in Lebanon and 6,000 refugees in Egypt, according to UNRWA statistics till February 2015.
- Al Husayneyya Camp: Regular Army is still preventing the residents of the camp to return back to their houses for 580 days respectively.
- Al Sheina Camp: Regular Army is still preventing the residents of the camp to return back to their houses for 561 days respectively.
- Handarat Camp: Residents have left the camp for 763 days after the Syrian Opposition Groups controlled it.
- **Dara'a Camp**: It is now almost **406** days without water and 70% of its buildings were demolished.
- Jermana, AL Saieda ZAinab, Al Raml, Al Aedein Camps in Homs and Hamma: A relatively quiet situation in light of the economic crises.
- Khan Al Sheih Camp: Roads linking the camp to the city center are still closed except for Zakia- Khan Al Sheih road.
