Recent Updates

Syrian regime forces targeted the Yarmouk camp south of the Syrian capital Damascus with anti-aircraft, where news reported that several lanes of the camp were targeted by the regular troops stationed on the towers of AlQaa area opposite to the camp, as a mortar shell hit the neighborhoods of the camp and resulted in only material damages.

In the meantime, a number of residents from Yarmouk confirmed that ISIS detained a number of civilians in the camp on charges of smoking in public places, noting that, in the south of Damascus, anyone who smokes in public places is detained for a full day by ISIS.



The regular army targeted neighborhoods of Deraa camp and Alsad road with mortar shells, while a land-to-land rocket "Al Fil" targeted a lane causing damages in people's homes, while there have been no reports of victims or injuries among civilians.

It is noteworthy that many Palestinian families who fled from Daraa camp live in Albalad area and Alsad road. The refugees in south of Syria suffer of difficult living and security conditions, while the rest of refugees

are suffering from very serious humanitarian situations reflected in the health and living sides, and the continuation of water cut off for (841) days, in addition to the shelling and repeated clashes, causing the destruction of 70% of its buildings and casualties according to unofficial statistics.

Turning to Lebanon, a number of Palestinian Syrian families complained from chaos and disorganization that accompanied the registration of data for the Palestinians of Syrian at Beit Jala UNRWA School in Siblin district in Kharoub southern Lebanon. Residents attributed the reason for that due to the failure of UNRWA to follow clear mechanisms for organizing and dealing with the large crowds that came of registration.

Some others believed that the registration period, which was determined for one day by UNRWA, was not enough, especially about 650 Palestinian Syrian families live in AlZina Valley, Katrmaya, Jadra, and Alshaheim are.

In turn UNRWA staff accused the people responsible for the chaos and lack of discipline and commitment to the system used, although UNRWA tried to give auditors serial numbers to facilitate their entry regularly, adding that some families insisted to enter before each other and provoke chaos.

Fainting and crises accompanied the data recording process as a result of overcrowding and waiting for long periods under the scorching sun.

It should be noted that UNRWA announced on July 25, 2016 for updating the data of the Palestinian Syrian families in Lebanon, and called all Palestinian families displaced from Syria until 24.07.2016 to go to

UNRWA centers based on days set for the refugees in its statement from 7:30 until 2:00 pm.



On the other hand, a number families of torture victims among Palestinians who died in the Syrian regime's prisons informed the AGPS correspondent that after notifying them by the security members of the Syrian that their sons died in prison, or after question about their fate through intermediaries or through the military court, Syrian security agents forced them to sign forged reports and death certificates issued from Tishreen military hospital, alleging that the cause of death was "heart attack".

The wife of one of the Palestinian victims said that after great suffering and agony and waiting to know the fate of her husband in Syrian prisons, she delivered a fake certificate after placing her signature on that paper that her husband died of a heart attack, and asked her to keep silence and not to ask about him again, and that she is lucky because she got that fake certificate "".

She confirmed to the AGPS that a released detainee informed her that he saw her husband after receiving this fake certificate. Meanwhile, activists stressed that a number of victims' families, who received these certificates, were informed by released detainees that they saw their relative detainees in one of the security branches or in Sednaya prison after the date of such forged papers.

It should be noted that the AGPS documented 447 victims among Palestinian refugees who died under torture at the hands of Syrian security forces since the start of war events in Syria.

The AGPS monitoring and documentation team confirmed that the number of Palestinian Syrian refugees who have taken refuge in the European Union since the beginning of 2011 till December 2016 has reached (79.206) refugees, based on the follow-up to a number of Statistics released by the UNHCR, the European Agency for the management of operational cooperation at the external borders of the Member States of the European Union (Frontex), and some of the statistics from the European Union and on the count of refugees to Europe.

With respect to the first half of 2016, it was noted most of the international authorities stopped issuing periodic reports on this subject, especially the UNHCR, and the IAEA European management of operational cooperation at the external borders of the Member States of the European Union (Frontex.)

If we take into account the continued arrival of refugees before the signing of the European Turkish agreement concerning the refugees, the

monthly number of January, February same estimated number, so the approximate number of the intersection of public statistics about (8000) Palestinian refugees. For March until June the number is no more than 1,000 refugees, making the total number of Palestinians for Syrian refugees who have arrived in Europe from 2011 till January 2016 up to (79 206), while emphasizing that the figure is approximate, without calculating the number of stranded refugees in Greece, due to the total absence of any statistics on their numbers.



Palestinians of Syria; Numbers and Statistics till 28\07\2016:

- 15500 Palestinian Syrian refugees are in Jordan
- 42.500 Palestinian Syrian refugees are in Lebanon
- 6000 Palestinian Syrian refugees are in Egypt, according to the UNRWA statistics till July 2015
- 8000 Palestinian Syrian refugees are in Turkey
- 1000 Palestinian Syrian refugees are in Gaza
- More than 71.2 thousand Palestinian Syrian refugees have reached Europe till the End of December 2015

- The Yarmouk Camp: siege, imposed by the Regular Army and PFGC groups, continued for 1137 consecutive days. Power cut continued for more than 1198 days, water was cut for 687 days respectively. The number of siege victims is 187.
- Al Sbeina Camp: Regular Army is still preventing the residents of the camp to return back to their houses for 990 days respectively.
- Handarat Camp: All Residents have left the camp for about 1182 days after the Syrian Opposition Groups controlled it.
- Dara'a Camp: It is now almost 843 days without water and almost 70% of its buildings were demolished.
- Jermana, AL Saieda ZAinab, Al Raml, Al Aedein Camps in Homs and Hamma: A relatively quiet situation in light of the economic crises.
- Khan Al Sheih Camp: Roads linking the camp to the city center are still closed except for Zakia- Khan Al Sheih road.
