"65 Palestinian Refugees were killed During August 2014 in Syria including 31 due to Torture"



- Three Palestinian refugees died due to torture, two of them in the Syrian Prisons and one by Al Nusra Front.

Statistics

The Action Group announced that 65 Palestinian refugees were killed during August 2014 in Syria including 31 refugees were killed in the Syrian prisons due to torture and three of them were killed by unknown groups in the Yarmouk camp. The three victims are Baha Saqer, Ahmed Al Sahli, Abdallah Bader and a refugee from Khan Al Sheih camp.

A mother and her son died due to the fire that broke out in the Bait Lahia UNRWA School in Khan Danoun camp. 4 refugees were killed due to clashes at Al Nairab camp in Aleppo between the Regular Army and the Syrian Opposition Groups in Al Shaikh Lutfi area.

Victims

Omar Mashlout from Khan Dannoun camp was killed due to torture in the Syrian prisons after being arrested by the groups of Al Khan checkpoint since months. Osama Al Tubasi from the Yarmouk camp was killed due to torture in the Syrian prisons. Farouk Abu Metha from Khan Al Shaih camp was killed due to torture by Al Nusra Front after being arrested for one month.

Yesterday, the Charity Committee for the Relief of the Palestinian People distributed a number of food baskets and bread to the Yarmouk Residents, where the UNRWA distributed food and medical aids to the Yarmouk camp.

The Action Group correspondent from inside the camp insured the injury of a young man in his hands and stomach by a sniper shot during the distribution of aids. He was immediately carried to hospital and he is in a critical status now in the hospital. On another side, some Palestinian families were allowed to enter the Yarmouk camp.

In terms of the Initiative of braking the Yarmouk siege, Mr. Nazmi Ghazal, the mediator between the parties of the Neutralization agreement, said that there is a lot of obstacles that were put in order not to make the initiative succeed, after all parties agreed they return to put new conditions to implement the agreement, most important is to enter fuel to the camp. The military groups accuse the Regular Army and PFGC in obstructing the efforts of breaking the Yarmouk siege. It is referred that the Yarmouk camp is 10 Km far from the center of Damascus, it is considered the biggest Palestinian refugees camp inside Syria. The Syrian Regime imposed partial siege on the Yarmouk camp since 10th of July 2012, where the Syrian Army closed all its entrances except the northern entrance before the complete control of the free army after that the Syrian Army and PFGC imposed a complete siege since 17th of July 2013, they prevented to enter the food materials, flour, medical materials and fuel and they prevented the entry and the exit of its residents.

In Damascus City, Khan Al Sheih camp witnessed a calm state with warplanes hovering around coincided with the power cut on the houses of the residents and explosion sounds were heard in the surrounding areas. A hornet's nest state prevailed Khan Al Sheih camp after the news of Farouk Abu Metha's death due to torture by Al Nusra Front after being arrested for a month. It is referred that the Syrian Opposition groups made some violations in Khan Al Sheih camp where they fired shots on the residents on 9th of July 2014 where two victims from the camp were killed Mohammed Methqal Al Qadeya and Mohammed Saleh Saleh and led to a number of wounded. On 16th of July 2014 groups of the Syrian Opposition break into the camp with fire shots in Al Madares and Al Makhfar streets which led to the spread of a worry and horror state amongst the residents and they arrested a number of residents to unknown places.

Therefore, Wael Abu Zahra from Khan Al Sheih camp was killed on 20th of July 2014 after being kidnapped by a group affiliated to the Syrian Opposition. Mohammed Khnaifes and Abu Irfan Khnaifes were released.

This group broke into the camp on 3rd of August 2014 and raid and inspect the house of Mohammed Jarawan Saleh searching for Moen Jarawan how is wanted for them and killed the young man Mohammed Jarawan. They also have raid the house of MR. Ahmed Al Rmly, a teacher in the UNRWA school and arrested him.

On the other hand, a number of notables and activists of Al Sbeina camp demanded the Syrian Government and the factions that loyal to it, to allow the residents to return back to their camp. It is mentioned that the Regular Army and a number of Palestinian factions Loyal to it are controlling the camp completely since 7th of November 2013.

Arrest

Jamal Al Shehabi was arrested by the PFGC during the distribution of food aids in Rama Street in the Yarmouk camp.

Civil Work Committees

Al Nour Charity Society for Relief and Development in cooperation with Jafra Organization for Youth Relief and Development in the Yarmouk camp announced the launching of the Polio Vaccine in the Yarmouk camp for Palestinian refugees southern of Damascus which is besieged by the Syrian Army.

Malta

A video was published on the pages of social media facebook shows the suffering of the Palestinians of Syria refugees in Malta as a result of assaulting them by the Maltese authorities and are being beaten specially women and old men to force them to fingerprint which will deprive them to reunite with their families in Europe and the Scandinavian countries. It is referred that the Palestinians of Syria and the Syrian refugees escaped from the ongoing conflict in Syria searching for safety and decent life. The refugees were shocked by the inhumane treatment that they received in the countries that they immigrated to.
