
### Recent Updates in Syria

Meanwhile, the people of Khan Al Shaih camp bury "Ahmed Al Ramly "who was killed because of the bombing which targeted the area around the camp the day before, while strong explosions rocked the camp by the explosive barrels bombing of farms and adjacent areas.

As for economic aspect, people suffer from a severe shortage of food, vegetables and fuel due to the blockade imposed by Regular Army, with repeated complaints of low level of medical services due to lack of medicines and medical supplies.

In a related context, the warplanes hovered above Daraa camp southern Syria coincided with the bombing of its vicinity, while people still suffering from lack of food and medicine and the continued power and internet outages from the camp for long time.

On the other hand, Khan Dannoun camp, located 28 km south of Damascus, which hosts thousands of displaced families from Yarmouk ,Sbeneh, Al Sayeda Zainab , Khan Al Shaih, Al Husseiniya compound, Al Theyabeia, Al Hajar Al Aswad town and adjacent areas . Al Dannoun camp suffers from the shortage of food supplies, medicine, the continued power outages and weakness in the communications network.

### **Tunisia**

UN High Commissioner for Refugees (UNHCR) Informed the Tunisian authorities that it will temporarily cover the settlement of residence in Tunisia as refugees for the benefit of the 11 Palestinians arrested in Al Iwa'a police station at Al Wareya, a month ago on charges of entering the country illegally, as well as Palestinian families who remained stranded for a week at Carthage Tunisian airport and then allowed them to stay for a month in tourist School at Al Hamammat area.

Thus, the Action Group for Palestinians of Syria has demanded the Tunisian authorities to release those arrested, treat them like the other refugees, and regarding the international laws and resolutions concerning the treatment of wars refugees.


#### Albania

Palestinian of Syria refugees, detained in Albania a few days ago, demanded the Palestinian Ambassador "Yasser Najjar," to an immediate interference in order to deport them rapidly to Greece.

According to the statement issued by the Palestinian Embassy in Albania, which the Action Group had a copy of it, that the Palestine Embassy in Albania got information that some Palestinian refugees came from Syrian camps to Albania through Greece, where they were transferred from Albanian Greek borders to Albanian detention center of refugees.

The Palestinian ambassador in Albania, "Yasser Najjar said, "The Palestinian embassy has contacted the competent Albanian bodies to check and see their conditions, as an agreement done with the Director of the detention center to secure some of their personal needs".

The statement emphasized that the director of the detention center confirmed to Al Najjar that the Albanian authorities waiting their deportation to Greece in the coming days, according to followed lows and agreements between Greece and Albania regarding the illegal refugees.
