Rescuing the refugees from drowning

Malta

A commercial ship rescued a boat that was carrying Palestinian and Syrian refugees, who launched their trip from the Egyptian beaches on 21st of August 2014, where their boat broke down in the middle of the sea. That ship was heading to Malta where the refugee bodies were handing there, amid reports of ill-treatment they were subjected to force them to thumbprint.

Victims

The corpse of the female refugee "Safaa Mohammed Taleb" was found in Al Maadamea hospital in Damascus city, as she was shot directly in head. It is mentioned that she was missed in 10th of August 2014 while she was heading to Qudseia town in Damascus city.

Recent Updates

Explosive barrels targeted Handarat camp in Aleppo, where at least two barrels dropped at the camp and resulted in massive destruction in civilian's houses and properties. It is worth mentioning that most of the residents were fled from the camp because of the repeated bombing, while the camp is fully controlled by groups of the free army.


Meanwhile, a mortar shell dropped on the eastern sides of Khan Al Sheih camp in Damascus city, which resulted in a state of fear amongst the residence because of the shrapnel that reached the inner lanes with no casualties. The camp is suffering of a severe shortage in health services, as the UNRWA dispensary is the only one who working in the camp and serve simple health services. The camp is suffering of the loss of many food supplies because of the repeated closure of the roads that connecting the camp to the adjacent areas due to the clashes and the bombing.

In the mean time, a mass march launched from the Yarmouk camp south the Syrian capital Damascus, after Al Jomaa prayer in front of Palestine mosque. The march launched to celebrate the victory of the Palestinian resistance to the Zionist enemy. The protestant chanted slogans of victory to Gaza and to the Palestinian people, confirming the unity of Palestinian ranks and the Palestinian people support to the resistance. They also called to break the Yarmouk siege and end up the humiliating status that experienced by the Palestinian people in the camp from "carton of Death" to detention at the entrance of the camp.

On the other hand, the UNRWA distributed food and health baskets to the Yarmouk camp residents who are besieged for more than 400 days. Relief and education organizations announced reaching an agreement to unite the teaching file inside the camp, that announcement came after numerous meetings held by these organizations to come up with a mechanism that aims to boost the educational process within the Yarmouk.

According to the statement issued by those organizations that all parties have agreed to recognize the following agencies as an official sponsor of the educational process in the camp, which are: Al Amal kindergarten, located in Al Iaasha building as responsible for Pre-primary education. Unify the first and second semesters in Al Jarmaq School, and merging the rest of the school teachers in the staff of Al Jarmaq School according to the experience and need.

While AbdulQader Al Husseini School considered to be the educational framework concerning the secondary school from the tenth to the twelfth grade. The statement stressed that these organizations are the only recognized formal educational bodies by all parties. The relief institutions role is to provide the required support at all levels to make the educational process succeed. The statement confirmed that a unified educational office has been formed consisting of the head of educational institutions and a representative of relief institutions to supervise the process of work. Any party that disregards this decision is regarded as a disobeying party and seeks individual gains regardless of the children best interest.

In conclusion, the statement requested from the General Authority for Palestinian refugees to support efforts to success the educational process in the Yarmouk refugee camp to ensure a bright future for the children.

In the AlSyeda Zainab camp, the remaining people suffer from a severe humanitarian crisis affected their livelihood as a result of the acute shortage of food supplies, and the lack of fuel and the continued power

Lebanon

The Lebanese General Department called all the Palestinians of Syria refugees in Lebanon to visit the security centers in order to settle down their position till 26th of September 2014 where they will be given residency of 3 temporary months for one time under a condition that their entry to Lebanon is not over one year.

It is mentioned that the Lebanese Authorities banned the Palestinians of Syria refugees to enter Lebanon but under some strict conditions which are not applied on them. The Lebanese authorities in the last months deported dozens of them to Syria in addition to not allowing renewing their residencies after their expired residency.
