Recent Updates in Syria

People of Khan Dannoun Camp in Damascus city suffer from a severe water crisis, according to a civilian, the main cause of the crisis caused by not pumping water regularly to the camp, in addition that the schedules of electricity and water are not synchronized, even people expressing that (water without electricity and electricity without water).

Um Mohammed added that the majority of the population began to rely on water tankers to fill up their empty tanks, and also noted that the prices of the water tank is getting high with the continued water cuts.

Thus, a number of activists and camp dignitaries called the General Authority for Palestinian Refugees and "UNRWA" to take responsibility and intervene to solve this problem. The activists also accused these authorities of failing because of that lack of communication with those involved in electricity and water organization.

It is noteworthy that Khan Dannoun refugee camp hosts thousands of Palestinian families who were displaced from their camps because of the bombing and siege.

On the other hand a state of calm prevailed in Yarmouk camp, coincided with the distribution of food aid, where aid contained a quantity of vegetables, fruit and bread.

Meanwhile, the Regular Army and groups of the Popular Front - General Command imposed a strict siege on the camp for more than ten months.

On the other hand, the Palestinian Popular Committee, in Alnairab camp, accused, in a statement posted on the pages of social networking, considering that as an attempt to displace the people of the camp, and it

Aid distributed yesterday in the Yarmouk refugee camp

Lebanon

The Lebanese Center for Human Rights and a number of local and international organizations in Lebanon declared, in a press conference, numbers of violations in the rights of refugees residing in Lebanon, including the Palestinian refugees,. One of the clear violations, according to the center, is the displacement of the Syrian Palestinian refugees. The Lebanese Human Rights Center considered all this as a violation of article III of the "UN Convention Against Torture" which Lebanon government signed. The formal prohibition for Palestinians from Syria to reside on the Lebanese territory, in breach of Article 14 of the Universal Declaration of Human Rights, which stipulates that « everyone has the right to seek and to enjoy in other countries asylum from persecution» These discriminatory measures against Palestinians from Syria have been followed by new decisions inconsistent with Human Rights, also targeting Syrian refugees: the latter are now prohibited to leave Lebanon on pain of having their refugee status withdrawn by the Lebanese authorities. This measure does not make sense in so far that the Lebanese authorities - which did not ratify the 1951 Geneva Convention on the refugee status have never recognized the status granted by the UNHCR. In other words,

the authorities refuse to recognize this status and its pertaining rights, but want to impose its constraints to the refugees. It is worth mentioning that the Lebanese authorities have deported 49 Palestinian refugees to Syria and three of them are still stuck on the Syrian Lebanese border. Moreover, Adham Mawerd, Husam Yateem and Mustafa Yateem refuse to go back to Syria because of the great risks on their life.

Civil Work Committees

The Charity Commission for the Relief of Palestine People in Aleppo distributed a number of food packages and blankets, as well as health aid provided by the Syrian Red Crescent on high school students, from Al Nairab Camp, who spend the exam period in the city residing with Palestinian families because of the difficulties of roads in Syria. It is worth mentioning that the Charity Commission will distribute dome aids on the organization headquarter at Al Shahba new area on next Sunday.

In Addition, the Charity Commission civil defense team continues to clean the Yarmouk camp streets where they clean the miss done by the missiles and mortars on separate places in the camp. It is worth to mention that the Charity Commission performed field visits to the injured people and the families of martyrs in the Yarmouk camp and gave them financial aids.
